Presentation

NEW JERSEY PACE

Jonathan Cloud was present to conduct the presentation. He discussed how New Jersey Municipalities can help provide energy efficiency and renewables for commercial, industrial, non-profit and multifamily property owners. The discussion included how NJ PACE works, its benefits to municipalities, what they provide as administrator and the Key program features.

Public Comment

On motion of Councilwoman Rose, seconded by Councilman Pedroso, the meeting was opened to the public.

Members of the public wishing to address the Council on any matter will be allowed two minutes to speak, unless there are unusual circumstances.

Rick Musser and Nancy Musser of Clare Drive were present. They are 15-yr residents and represent about 50-houses on Clare Drive. Mr. Musser advised that 22 and 24 Clare Drive are homes that have been condemned for 12-years. He commended the Administrator and his staff for working with them over the years but added there remains great health and safety concerns plus a tremendous liability for the Township that needs to be remedied immediately.

Township Administrator Naples advised that he along with our legal department continue to work together to remedy this blighted condition as far as the law will allow. Council asked that Township attorney Savo provide them an update on where they are with this in the near future.

Robert Fallston, 311 Milltown Road, Bridgewater was present. He questioned what the Township's plans are concerning the animal shelter. He was advised that Council voted to continue providing animal control services through calendar year 2015.

Dorothy Driscal, 16 Claire Drive was present. She questioned the timeline for action from the Township concerning the two condemned homes on Claire Drive. Council could not provide a timeline in public session due to the threat of liability.

Michael Croloff, 25 Claire Drive was present. He reiterated the blighted conditions on 22 and 24 Claire Drive and asked for a resolution in the very near future.

Andy Leven, 2 Holmes Court was present. He spoke concerning the issue before Township Council regarding the request to authorize the Planning Board to investigate whether the sanofi site is fit for redevelopment. He asked that Council retain experts who will investigate for the Township and provide an independent and unbiased read of whether the sanofi site is in need of redevelopment. Mr. Leven further noted that Council should also require this developer to pay for these the experts.

Bob Vaucher, 149 Foothill Road was present. He stated he is concerned with the sanofi redevelopment. He recommended a blue ribbon committee to review this proposal and provide a report.

John Schmitt, Woodfield Road was present. He is the president of the Economic Development Advisory Committee (EDAC). He advised the EDAC has been advised of the sanofi redevelopment proposal and so far, they are in favor of it being investigated by the Planning Board and would like to be a part of this process.

Simone Gawn, 607 Somerset Street was present. She spoke in favor of forming a committee to review the proposal for sanofi's redevelopment to alleviate any concerns with this process.

Teresa Aven, Drysdale Lane was present. She stated she is against the redevelopment and asked there be caution while redeveloping this property.

Michael Bessasparis, president of Somerset Hills Towing was present. He stated he would have liked to be involved in preparing/critiquing the towing Ordinance that is on the agenda today. Mr. Bessasparis was advised Manny Caravela, Bridgewater Police Chief did meet with a number of towers and the president of the Towers Statewide Association who helped in developing the towing Ordinance.

Bob Vaucher, 149 Foothill Road reiterated the need to have a blue ribbon committee to review the sanofi redevelopment proposal.

On motion of Councilman Norgalis, seconded by Councilwoman Rose, the public comment session was closed.

AN ORDINANCE AMENDING CHAPTER 216 ENTITLED “WRECKERS,” OF THE MUNICIPAL CODE OF THE TOWNSHIP OF BRIDGEWATER, COUNTY OF SOMERSET, STATE OF NEW JERSEY SO AS TO 1) CLARIFY THE TERMS “EXTRAORDINARY TOWING SERVICE,” “LIGHT-MEDIUM DUTY WRECKER,” AND

The motion was seconded by Councilman Pedroso and carried on a unanimous voice vote although Councilman Norgalis said he was satisfied with the extensive documentation provided by the police department in response to his comments on the original document.
