#### Adoption of the 2012 Budget

At 7:37pm Chairman Kurdyla has made a motion to closes the regular portion of the meeting Commissioner Paul Orloff seconded the motion. Commissioner Carl Spolarich has made a motion to open to the public Commissioner Orloff seconded the motion. Commissioner Spolarich now is going to present the 2012 budget to the public. The total budget for 2012 is \$546.896.00 which is up from \$537,436.00 in 2011. The taxable portion will increase from \$493,798.00 to \$510,758.00. The budget for 2012 has an increase of 2%. This increase will be put in the 713.0 category Maintenance & Repair Account. The Main thing is we are governed by the state keeping us at a 2% cap. The ratable jumped we did a little better; this does include our funding towards replacement apparatus. Chairman Kurdyla has asked if anyone has any questions on the budget. The additional expenditures this year will be the department physicals. No questions from the public
