- 1. On December 14, 2010 the Courier News posted the Bridgewater Fire District #4 Annual Election Public notice the 2011 Meeting dates and the Public Hearing notice for the 2011 budget.
- 2. On December 25, 2010 The Courier News also posted the notice for mail-in ballot for Bridgewater Fire District Elections No.1, No.2, No.3, and No.4. Commissioner Spolarich stated he hasn't seen any other fire districts do this. Chairman Kurdyla is looking for the Boards approval to split the expenditure for the ad with the other districts. All members in favor of splitting the cost.

Public Hearing Notice for 2011 Budget

At 7:47pm Chairman Kurdyla has made a motion to closes the regular portion of the meeting Commissioner Ranallo seconded the motion. Commissioner Ranallo has made a motion to open to the public Commissioner Orloff seconded the motion. Chairman Kurdyla now is going to present the 2011 budget to the public. The total budget for 2011 is \$537.436.00 which is up from \$525,538.00 in 2010. The taxable portion will increase from \$481,900.00 to \$493,798.00. The budget for 2001 has an increase of \$11,898.00. This increase will be put in the 713.0 category Maintenance & Repair Account. The Main thing is we are governed by the state keeping us at a 2% cap. This does include our funding towards replacement apparatus, the insurance was around \$93,000 about 20% of the budget, 40% of our budget is locked into two of our categories. Chairman Kurdyla has asked if anyone has any questions on the budget. Resident Bill Wilde has asked how much is in our capital, the answer is around \$500,000.00 the Asset evaluation in the district was down, with the new STS building were up a little. The additional expenditures this year will be the department physicals. Commissioner Spolarich stated that the ratable is down 20 million. With no one else to be herd from the public a motion to close the public portion of the budget hearing Commissioner Spolarich makes a motion and Commissioner Orloff seconded the motion to close and re-open to the regular scheduled meeting at 7:55pm.
