Robert and July Margist - 203 Old York Road Block 122, Lot 9 #12-01-PB, Simple Variance (300 sq. ft. addition)

Mr. Robert Margist was present and no attorney represented the applicant. Township Engineer, Mr. Robert C. Bogart provided detailed information pertaining to the nature of the application. An addition to an existing single-family dwelling was proposed and presented to the Planning Board due to the site being located in a flood plain area. Mr. Bogart confirmed that the property is required to maintain flood insurance.

Mr. Margist stated that he would like to construct a small addition to his existing home and further explained that the driveway would remain the same and the expansion is a modest addition. He testified that he is not interested in the erection of a second story addition.

Chairperson Joanne Kane opened the hearing to the public for questions and comments:

Mr. Lomanstro – 200 Old York Road – Bridgewater, NJ. Inquired about the addition and it there would be water run-off onto neighboring properties.

Mrs. Lomanstro – 200 Old York Road – Bridgewater, NJ. Concerned with excessive flooding onto properties.
