#### **NEW BUSINESS:**

- Budget Chairman Kurdyla had received a call from the State stating the number for the budget was reported wrong.
  We need make a copy of the budget page and send it to the state, our budget was set for the 900 mark and we should stay with that. A motion has been made by Chairman Kurdyla to send a letter to Dept. of Community Affairs, Carl Spolarich 1<sup>st</sup> the motion and Tony Ranallo 2<sup>nd</sup> the motion all in favor.
- 2. <u>County Meeting concerning the Ultra High</u> Chairman Kurdyla reported that the company is doing an inventory on the equipment we currently have and then will discuss with a consultant and where we are going. The inventory will be done in a couple weeks, no action needed by the board at this time.
- 3. <u>Insurance</u> We need to give them a membership roster and calls for the year, first is the roster for coverage, members who are not in town and don't come to calls are not covered. In addition to possible coverage for a Ladies Auxiliary members would be \$265.00 per person annually. <u>Bound Brook's Truck</u> we need to protect ourselves, if there truck damages our building they will be responsible plus we will not be responsible for any damage to there truck. <u>Squad Rigs</u> We need to change our position with the squad rigs. I've been informed that the underwriters for the insurance company do not want to continue coverage on the current arrangement. The board is not in a position to hand over the rigs to the squad because they were purchased with taxpayer's money. One possibility for the board is to establish a lease agreement with the Rescue Squad then there insurance will not hold us responsible, but if anything happens to the rigs then the district will be compensated. Tony Ranallo will set up a meeting with the Squad to further discuss.
- 4. Chairman Kurdyla has stated for the record that the correspondence from the Fire Company is not acceptable.
- 5. <u>Air & Gas Tech. 2010 contract</u> \$1870.00 Tony Ranallo made a motion to accept the renewal and Chris Fernandez has 2<sup>nd</sup> the renewal.
- 6. <u>Banking Accounts</u> Carl Spolarich states right now were only getting ½ % on our current accounts, if we combine our accounts with TD Bank the interest rates will be better. Chairman Kurdyla has made a motion for Carl Spolarich to move forward with establishing a new account with TD Bank, Tony Ranallo 1<sup>st</sup> the motion and Chris Fernandez 2<sup>nd</sup> the motion to move funds.
