OLD BUSINESS:

- 1. Chairman Kurdyla will be attending the Relief meeting to appeal the decline of Craig's death benefit.
- 2. Chief reports that both the Bound Brook Engine and Fire Prevention Trailer are gone.
- 3. Department Physicals The board wants to make sure everyone is aware of the details of this proposed policy. Bridgewater Medical Group has submitted a cost proposal explaining both levels of testing (See Attached). The objective is to show if a member is fit to perform his or her duties. After that it is up to the member to address any issues that may come up. This physical will consist of two parts, Part-A will be full evaluation to perform interior fire

operations, and a Part-B will be a fire ground operations. Again Chairman Kurdyla asked the Chief if this has been addressed to the fire company, Chief Mangino said yes, and that he recommends the Bridgewater Medical Group be the primary doctors for this department, and the doctor will give the OK not the department. Chairman Kurdyla also advises that if a member is flagged they don't get credit for anything. The Board has a request that if member has insurance then the board will cover the Co-pay and if not then the Board will pick up the full amount. The Boards position will be to receive the report from the doctor stating a pass or fail and receive a copy of the report for the minutes to reflect the status of each member. Will the board pay for the follow up visit to the doctor if a member fails the first evaluation, we will only be asking them to sign off once the member see there doctor to address the problem. Chief Mangino the line will write a policy. Ed Zuromski – If a member fails the interior then the member will have to at least qualify for fire ground, if a member fails both then they can't respond at all. If the person fails to comply then a suspension will be applied. Commissioner Spolarich – Can we do this as a policy or amend our by-laws. Are we going incorporate the regular physical when a member starts? Chairman Kurdyla lets keep the physicals separate and we will check with the township to see if combining to two will work, Commissioner Ranallo was wondering about the time period between the two physicals, do we require the second part before the academy just incase the person gets flagged. The Fit Test will still be needed but only the mask part, the Pulmonary is included. Chief Mangino the by-laws will go to the company first and then back to the board. Chairman Kurdyla has asked that the company vote on this change, and will need to look at the budget for next year, Chairman Kurdyla has asked for a motion to move forward as discussed Commissioner Ranallo 1st and Commissioner Spolarich 2nd.

4. NJ State Of Fire Districts Dues – Commissioner Spolarich has made a motion NOT to pay the dues, Commissioner Orloff 2nd the motion.

NEW BUSINESS:

- 1. Commissioner Ranallo was contacted by the squad concerning the registration/title of the rigs and if the documents should go to the squad. The underwriters questioned the lease, the lease agreement is valid, if we were to give the rigs to the squad then a voter approval will be needed it's a township asset.
- 2. Losap & VFIS Policy requesting that every member update the Beneficiary Card for the insurance.
- 3. Chief Mangino has reported to the board that one of the Scott Air Packs is missing off of Engine 101. Last Sun/Mon all packs were accounted for, Saturday night member C. Howard noticed that it was missing during the fireworks detail and informed the chief. Commissioner Spolarich is currently reviewing video footage and Chief Mangino will gather the information on the missing pack for a PD report.
