- 5. Commissioner Ranallo The UL testing on Truck 30 are all minor repairs, currently Fire and Safety is fixing the failed areas and all the old hoses are being replaced. Once Fire and Safety completes the work Truck 30 will be taken to get the new Air System then UL Re-Test can be scheduled.
- 6. First Week of Oct. the Rescue and Engine 98 will be serviced from the storm work, it's possible we could be down a Truck and an Engine during these services.
