- 8. Received a copy of a report from the FCC on our current radio frequencies for District 4. The Chief is reminded by an accidental MayDay call on the East Main St. fire and that if it was real he would have needed another channel. After reviewing channel three that we use we are not lic. for 150797 the portables are not narrow band radios so the frequency is botched. The VHF System is out dated. In addition on another call at STS we were unable to use the VHF system and switched over to the county radios which worked. The County has 10 channels were on Ops 2 there are more options. Chairman Kurdyla we want to go to Ultra High, Martinsville system has faults; Green Knoll has problems because of changes. We need to get in sink with Bridgewater they haven't decided which way to go, County has room, it will take \$100,000.00 to transfer, we have to be part of the study and once established then we might be able to get a grant. The County audit we need, plus coordinate with Bridgewater. The Chief wants a reliable system and it could take a year and a half to make a change and next year we could be cut off. Chairman Kurdyla has spoken to Doug and there is something, we need the survey complete and position ourselves to get funded or fund it ourselves, there are budget requirements with Bridgewater also. If we have issues with Bridgewater then we will have to go through the right steps with them, this is not a commitment but were looking. Chief schedule a meeting with Manning and let Allen know.
- 9. The Mini Pumper is running like a champ.
- 10. Physicals The Company approved at the last meeting, don't think we need a by-law change we are going to keep it in our regular physical requirements, the insurance was covered and the doctor will try to accommodate, we are going to make a policy.
