T-Mobile Northeast LLC - 606 North Bridge Street Block 500, Lot 1

#03-10-ZB, Minor Ste Plan w/ Variances (installation of flagpole tower)

Attorney Gregory Meese was present to represent the Applicant. Sworn testimony was presented by Real Estate Appraiser Robert F. Heffernan who was hired by residents in opposition to the Applicant's proposal. Additional expert testimony was presented by the Applicant's Real Estate Appraiser Mark W. Tinder.

The hearing was carried from 3/27/12.

Several exhibits were submitted in opposition and admitted into evidence as listed on page one of the attached Certified Transcript of the 4/3/12 Board meeting.

Attorney Meese objected to the 9/19/2000 Vernon Township Zoning Board of Adjustment minutes being admitted in evidence as they are a summary of the meeting and not a transcript. They were not admitted into evidence.

Members of the public were present as follows:

<u>Joseph Kirk</u>, resident/attorney of 6 Overlook Drive, cross-examined the Applicant's Real Estate Appraiser Mark W. Tinder, who previously worked for Robert McNealy Vance in Somerville, NJ.

<u>Andrew Leven</u>, resident/attorney of 2 Holmes Court, cross-examined the Applicant's Real Estate Appraiser Mark W. Tinder.

<u>David Robinson</u>, 15 White Street, addressed concerns about the value of his property if the tower is approved, noise from the flag, and he requested a bond for the removal of the tower if abandoned.

<u>Kwokei Ng</u>, 8 Brian Drive, addressed concerns about the value of his property if the tower is approved.

Marion Slepian, 5 Overlook Dr., spoke in opposition as her scenic view will change if approved.

<u>Shawau Lao</u>, 3 Ivy Lane, too close to Temple Shalom and he is concerned about the effects on children.
