Public Comment

Township Administrator Naples advised they are aware of the problem and are working to rectify it. This would be handled if there are funds available in the 2014 road capital budget.

Boy Scout Nick Ollo of Troop 88 was present for Citizenship and Community Merit Badge. He discussed the pot holes concern throughout the township. He also asked about volunteer opportunities with the Township. He was advised to

contact Township Administrator Naples to further discuss volunteering.

Bill Metz, 45 Shannon Road was present. He inquired about repairing the second part of Van Holten Road and the broken slides at Brown Park. Township Administrator Naples offered administration is aware and a plan is underway.

Council President Moench invited those present to discuss the Lane Brokaw house.

Don Esposito, 16 Running Brook Road was present. He noted he is the chairman of Somerset County Cultural and Heritage Commission's Grant Committee. As a resident, he urged Council to authorize the application to the Somerset County Historic Preservation Grant Program for the Lane Brokaw house noting it is the last outstanding Dutch plantation house in Somerset County and possibly in New Jersey. He added George Washington came in person to this home to offer condolences to Mrs. Brokaw's wife after the passing of Mr. Brokaw. Because of this home's historic significance and the structure itself, it will receive the highest priority in the next County grant program.

Larry Powers, 14 Campbell Court was present. He advised that a poll conducted by Somerset County Cultural and Heritage Commission found that 97% of the people in the County agreed that historic preservation related programs were important. He provided some history on this home from 1881.

Jesse Havens, a non Bridgewater resident stated she is interested in Somerset County history.
