#### **Road Tour**

Mr. Bogart distributed a packet to the Council including maps and a more detailed description of the specific road and drainage projects, sidewalk projects, sewer utility and public works projects for 2015.

Mr. Bogart narrated during the bus tour. The tour concentrated on various road conditions, storm drainage and road surfacing techniques that would be utilized in the proposed capital improvement projects for 2015.

The tour covered various sections of the township. Mr. Bogart explained techniques likely to be used for this year's improvements, including the use of slurry and chip seals, which if applied as part of the initial program or shortly thereafter increases the lifespan of the roadways.

Mr. Bogart noted the extreme weather conditions this winter will have a huge effect on the roadways with potholes and repairs continuing through the spring.

Carmin de Falco, CEO of FinCredit Inc. was present to discuss the shop local program. He explained they offer a property tax reward program which provides property tax credits as an incentive to shopping locally. A "Shop Your Town" property tax card, similar to a reward card is made available to all township residents and upon enrolling in the program, residents may use the card and accumulate property tax credits every time they shop at local participating businesses. Renters are also eligible to register and get cash rebates but rent accounts are subject to a check handling fee which is deducted from the rebate. Yearly, FinCredit will transfer funds to the township crediting the tax bill of participating residents. There is no cost to the Township.
