- ✓ Residents will have the opportunity to bike with Mayor Hayes from the Bridgewater Senior Center at 455 Somerville Rd to Kid Street Park, 100 Commons Way, to participate in the Eco-Blast Fair
- ✓ Bicycle Ride to be provided with Emergency Vehicle Escort

Eligibility:

- Cyclists must be 18 years of age or older or accompanied by a parent or adult
- Cyclists are responsible for providing their own bicycle and other safety equipment including a bicycle lock and helmet
- Cyclists must register with Bridgewater Township prior to the Eco-Ride or the day of the event.

How to Participate:

- Complete and return the registration form by email or fax. Registration form can be found at www.bridgewaternj.gov or at the Bridgewater Health Department or Recreation Department
- Arrive to Bridgewater Senior Center at 455 Somerville Road, Bridgewater, NJ 08807 between 10:00 am and 10:30 am on May 2, 2015 to meet Bridgewater Mayor Dan Hayes and other cyclists. Bike to the Eco-Blast Fair at 10:30 am and enjoy the event. Shuttle service will also be available from the Senior Center to and from the Eco-Blast Fair.

I acknowledge that I may incur minor injuries, major injuries, and catastrophic injuries including paralysis and death. I assume all risks from contact with other participants and volunteers, negligent or wanton acts of other participants and volunteers, any defects of conditions of road surfaces (including uneven or wet road surfaces or gravel on the road surface), failure of cyclists, vehicles, and non-participants to observe traffic signals or laws, and the effects of weather including high heat, thunderstorms, lightning, precipitation, cold temperatures, high winds, and/or humidity. I assume all risk for any and all activities in addition to cycling that I engage in throughout the entirety of the Eco-Blast event during May 2, 2015 from the beginning to the conclusion of the event. I agree to dress myself appropriately as to mitigate risk of physical injury to myself including, but not limited to: wearing shoes appropriate for cycling and dressing in conjunction with the weather. I understand that wearing a helmet that satisfies Consumer Product Safety Commission ("CPSC") standards is highly recommended to participate in Bike to Eco-Blast. I acknowledge the recommendation to wear a helmet that satisfies CPSC standards for the entirety of my participation in Bike to Eco-Blast. I agree that the Bridgewater Township is not responsible for any personal items or property lost or stolen before, during, or after Bike to Eco-Blast.
