WHEREAS, N.J.S.A. 40A:14-81.4 allows reimbursement to volunteer and emergency service personal for losses and expenses incurred in the performance of their duties; and

WHEREAS, it is the intent of the Fire District to budget for this purpose; and,

WHEREAS, the Fire District desires to reimburse the volunteer firefighters and emergency service personal for expenses incurred relative to use of their vehicles clothing and such other miscellaneous expenses concerning response to fire, drill and any other firematic or emergency activities and it is not possible to specifically document these expenses thereby providing receipts which would otherwise be required; and,

WHEREAS, the fire district shall reimburse each active firefighter or emergency services personal who satisfies a certain percentage attendance at fires and drills and emergency activities, as determined by the Chief / President of the Martinsville Department and approved by the BOFC District #1, such sum on an annual basis for reimbursement for expenses incurred as previously set forth herein.

NOW, THEREFORE, be it RESOLVED by the Commissioners of Fire District # 1 in the **Township** of **Bridgewater**, County of **Somerset**, as follows:

- An annual reimbursement for expenses incurred for volunteer firefighters and emergency service personal is hereby established.
- (2) The Chief or President shall provide a list of members that have achieved the established Goal to receive this reimbursement and shall submit a signed/certified copy to the BOFC Fire District #1 prior to receiving same.
