#### Public Comment

On motion of Councilwoman Rose, seconded by Councilman Pedroso, the meeting was opened to the public.

Anda Cytroen, 654 Stangle Road in Bridgewater was present. She stated it is great that Council recognizes the need to make road improvements noting the roads in her area need attention. While she is pleased that the initiative has begun, she questioned the methodology to the five year capital improvement plan and the interim plan and when that will become public. She also questioned whether Council is satisfied with that approach as described by Administration.

At a later time in the meeting, Township Administrator Naples explained the 2017 Capital Project Plan will be presented to the Council shortly. Each year, the governing body reviews and tours selected roads throughout the township and then prioritizes which roads are to be repaired. They make significant effort, with the limited funding we have, to ensure each part of the Township receives some road improvement on an annual basis.

Township Attorney Savo added that the Master Plan encourages that the Township zone properties for what is actually on them and therefore this Ordinance allows us to be consistent.
