Chapter 99 of Bridgewater Codes requires all businesses within the Township to be inspected by the Township Bureau of Fire Safety. This ordinance also requires businesses to pay an annual registration fee to the Township of Bridgewater based on total square footage. **Each Building/Business is assessed separate fees for the same property.**

Please submit the registration fee with the enclosed form to: **Bridgewater Bureau of Fire Safety, 100 Commons Way, Bridgewater, NJ 08807.** Use the enclosed fee schedule to calculate your required fee. Checks should be made payable to "Bridgewater Township".

If you have any questions, please call the **Bridgewater Bureau of Fire Safety at (908) 725-6300 ext. 5550** during business hours of 9:00 a.m. to 5:00 p.m., Monday through Friday.

Exception: If your business is registered with the State of New Jersey Division of Fire Safety as a Life Hazard Use, you are not required to pay the registration fee.
