#### Discussion

VANDERHAVEN FARMS

James J. O'Donnell was present of behalf of the Vanderhaven Farms Association. He explained there is a pond at Vanderhaven Farm property. For years, they have had a "No-Trespassing" sign and fence around this area as non-residents are not allowed to fish on this pond due to liability issues. Last month, there were three (3) different incidences of trespassers that turned hostile and the police were called to intervene.

Mr. O'Donnel stated their request is for an Ordinance that would allow Bridgewater Police to patrol the area and issues summons.

Following a lengthy discussion, Council was in consensus that Vanderhaven Farms Association representatives will meet with Township Administrator Naples and Police Chief Nicaretta to determine best way to move forward.

# Introduction of Ordinances

AN ORDINANCE OF THE TOWNSHIP OF BRIDGEWATER 1) CREATING A NEW SECTION 126-318.1 ENTITLED "OFFICE, RESEARCH AND DEVELOPMENT (OR/D) ZONE" WITHIN CHAPTER 126 (LAND USE) OF THE MUNICIPAL CODE OF THE TOWNSHIP OF BRIDGEWATER, 2) AMENDING CERTAIN ANCILLARY ORDINANCES RELATED TO THE CREATION OF THIS NEW ZONE AND 3) AMENDING THE ZONING MAP TO REZONE CERTAIN PORTIONS OF LOTS 17, 18 & 19 IN BLOCK 483 ON THE BRIDGEWATER TOWNSHIP TAX MAP FROM THE ZONING DISTRICT KNOWN AS THE SPECIAL ECONOMIC DEVELOPMENT (SED) ZONE, SECTION 126-320 OF CHAPTER 126 (LAND USE), TO THIS NEWLY CREATED ZONING DISTRICT TO BE KNOWN AS THE OFFICE, RESEARCH AND DEVELOPMENT(OR/D) ZONE," SECTION 126-318.1 HEREIN, SO AS TO BRING IT ALL INTO CONFORMANCE WITH THE TOWNSHIP 2016 MASTER PLAN, AMENDMENT TO THE LAND USE ELEMENT AND RE-EXAMINATION REPORT AND ITS ADOPTION BY THE TOWNSHIP PLANNING BOARD

Township Planner Doyle explained the need for this Ordinance as follows:

The Council adopted regulations regarding the Redevelopment Area known as the Center of Excellence which is a portion of Block 483 Lots 17, 18 and 19. Prior to its being designated as a Redevelopment Area, the entirety of the lots were in the SED zone. After the area was designated as an Area in Need of Redevelopment, the Council rezoned the portion of the lots as the Redevelopment Special Economic and Employment Development District (R-SEED) zone.

The Redevelopment area lies along Route 202-206 North and is the easternmost portion of Block 483 Lots 17, 18 and 19. To the west of the Redevelopment Area is the remainder of Block 483 Lots 17, 18 and 19 which are collectively comprised of an established industrial research and development campus. This portion of land still remains in the SED zone, although it no longer meets the development standards for the SED zone.

The proposed ordinance addresses the need to bring these 'backlands' into conformance with their current use and the geometry of the site. The proposed ordinance achieves this objective.

The benefits of the ordinance amendment include:

- Specific regulations for the OR/D zone will define the specific parameters under which the remaining portion of the SED zoned lands can operate. Since there is another location in town where the SED is located, a new zone is needed to assure consistency with the existing uses and the need for conformance with the zoning ordinance.
- 2. The development regulations for the OR/D zone will assure that the industrial research and development corporations will be able to continue without being burdened with conflicting interpretations on the use and intensity of use.

Township Planner Doyle fielded questions from the governing body. Councilman Pedroso explained that although he does not have an issue with the uses on this zone, he does have an issue with the approval of the redevelopment plan that took place last year. Being he feels this area is already overdeveloped, he would prefer that the applicant is forced to go to the zoning board for future considerations to develop this property rather than approving the request to rezone it.
