Discussion Councilman Norgalis stated that he attended the bid openings last week for road work on Colonial way, Dogwood Drive and Braemer Place all of which are on our agenda for tonight. It is now apparent to him that the "CAPITAL BUDGET 2017 for ROADS" worksheet that was approved as part of the Capital program is inconsistent with the scope and expense of the work actually done. Streets such as Victor are added by the Administration and the scope of work for others such as Braemer are increased.

Councilman Norgalis requested the Capital work sheet be amended and provided to Council on an ongoing basis and to include columns for Engineering and Final Cost and where appropriate, annotated for scope changes. He stated this request is not being critical of Road Capital projects but is simply to facilitate keeping the Council up to date.

ALL INTO CONFORMANCE WITH THE TOWNSHIP <u>2016</u> MASTER PLAN, AMENDMENT TO THE LAND USE ELEMENT AND RE-EXAMINATION REPORT AND ITS ADOPTION BY THE TOWNSHIP PLANNING BOARD

Township Attorney Savo explained that this Ordinance confirms what currently exists. This is a property previously designated as an area in need of redevelopment and as such is being rezoned as recommended by the Planning Board. This Ordinance allows us to adopt that recommendation.
