Minutes

NOVEMBER 30, 2017 - AGENDA SESSION DECEMBER 4, 2017 - REGULAR SESSION

On motion of Councilman Norgalis, seconded by Councilwoman Rose, the November 30^{th} agenda session minutes and December 4^{th} regular session minutes were moved for approval and passed unanimously on a voice call vote. Councilman Moench abstained on the November 30^{th} minutes.

Council Reports

Councilman Norgalis:

- Attended the Somerset County Republican Holiday Party at the Char Restaurant in Raritan.
- Attended, along with Attorney Alex Fisher and Township Planner Scarlett Doyle, the final Court approval by Judge Miller of the Bridgewater COAH plan. Judge Miller was very complimentary of Bridgewater's efforts over

- many years to provide affordable housing.
- Attended, with great sadness, the viewing for Bridgewater Health and Human Services Director Chris Poulsen who passed away at the 54 years of age. Chris had 32 years of faithful service to the Township and he will be solely missed.
- Attended the Somerset County Business Partnership Annual Meeting were several businesses and organizations were honored for their positive impact on the county.
- Wished everyone Happy Holidays

Councilman Moench

- Remarked the passing of Chris Poulsen, Director of Human Services is a great loss to the Township and to his family
- Announced that Bridgewater Cares initiative that he and his wife created to encourage volunteerism and community service is in its third week. The goal of this initiative is to encourage non profits and community service organizations to talk about what they do to in order to inspire people to volunteer
- Spent time volunteering at different organizations including the Raritan Pregnancy Aid and Information center and Somerset County Food Bank
- Advised that the Rutgers division of Addiction & Psychiatry conducts events where they visit a community to train about the use of Narcan which is a drug that reverses the effects of a drug overdose. They also give out free kits. Councilman Moench has partnered with them and has set up a meeting for Tuesday, January 23rd at Centerbridge II at 7PM. Only 25-spots are available. More information will be shared soon.

Councilman Pedroso

- Shared in the sentiments regarding the loss of Chris Poulsen
- Attended the County GOP Holiday party.
- Attended Centerbridge's Holiday event
- Attended Assemblyman Peterson's annual breakfast where Santa made a special visit
- Wished everyone Happy Holidays

Council Vice President Rose

- Stated the loss of Chris Poulsen, Director of Human Services is significant to the Township and community and hoped that his contributions will be remembered and perhaps memorialized
- Attended the Friends at Bridgewater History meeting where a presentation was conducted by the Hobbs family as they are getting ready for the 200th anniversary of the founding of Hobbs Town. A big family reunion has been planned for 2020

- Attended the Creative Arts Committee reception which continues to demonstrate the great level of talent we have in the community
- Attended the County Alliance Steering community meeting of which she is a member. There was a presentation by Robert Wood Johnson about a program which essentially puts a recovery specialist in the emergency room for patients who have been administered the Narcan drug. That specialist keeps in touch with these individuals in hopes they can get them into a rehabilitation and beyond for approximately 6-9 months.

Council President Kurdyla

- Had an Open Space meeting scheduled this past Saturday. They will soon be proposing 4-properties for consideration by the governing body
- Remembered Chris Poulsen, Director of Human Services with fondness noting he was a great person and will be dearly missed
- Read a document last week from resident Charles Isely with concerns over regulations by the State of NJ regarding bee keeping. He stated that at this time, Council does not have any information on that from the State. However, to address the concerns of our residents, we will give every resident the opportunity to present their opinions.

Mayor's Reports

Thanked the governing body for their comments regarding Chris Poulsen. He stated Chris was a colleague and friend for 14-years and in those years, he never had a bad day and if he did, he never made it anyone else's bad day. As an administrator and friend, he appreciated him. On behalf of the Mayor, Township Administrator Naples stated they are working on something that will commemorate his service to the Township.

Discussion

LANE BROKAW HOUSE

Councilwoman Rose stated she appreciates administration's assistance in gathering some of the data required for this meeting. She added there are more questions that remain unanswered and therefore will not be in a position to continue discussions tonight pending the receipt of those additional pieces of information that we need. As such, she requested that items 12a and 12b that are currently listed on the agenda be tabled.

Public Comment

On motion of Councilman Moench, seconded by Councilman Pedroso, the meeting was opened to the public.

Members of the public wishing to address the Council on any matter will be allowed two minutes to speak, unless there are unusual circumstances.

Charles Isley, 704 Kline Place was present. He stated he was present to make Council aware of the NJ Department of Agriculture's proposed beekeeping

regulations that he felt will severely restrict beekeeping in the State and consequently in Bridgewater Township. He opined the department of Agriculture has ignored the intent of the law that directed it to produce these regulations noting that said rules will severely restrict beekeeping in both urban and rural areas of the state and impose onerous requirements on beekeepers that are not supported by sound science and facts. He added that these rules were drafted without consulting adequately with the NJBA or utilizing the beekeeping expertise that exists in NJ Department of Agriculture. Mr. Isley asked that the Council review those changes in the hopes they can oppose same.

Bonnie Pyler, President of the Morris/Somerset chapter of NJ beekeepers was present. She stated that beekeeping is integral to farming, agriculture, livestock etc and added that limiting the opportunity to keep bees is unfair. She asked that after Council reviews those regulations, they consider the immediate and long term effects of limiting or eliminating beekeeping then pass a resolution that Bridgewater Township will not support the proposed regulations.
