## **CSDMACPFE**

The application fee for a certificate of smoke alarm, carbon monoxide alarm & portable fire extinguisher inspection compliance as required by N.J.A.C. 5:70-2.3, shall be based upon the amount of time remaining before the change of occupant is expected, as follows.

## **Requests for a CSDMACPFE**

- 1. received <u>more</u> than 10 business days prior to the change of occupant is \$60.00 (includes 1<sup>st</sup> failure re-inspection
- 2. Requests for a CSDMACPFE received four to 10 business days prior to the change of occupant is \$90.00
- 3. Requests for a CSDMACPFE received fewer than four business days prior to the change of occupant is \$170.00
- 4. After 1<sup>st</sup> failure and a subsequent re-inspection is required and thereafter an additional fee of \$25.00 shall be paid prior to the 2<sup>nd</sup> re-inspection and so forth.
- 5. Waiver request for CSDMACFE inspection & requirements shall be charge a \$20.00 administrative handling fee. (house to be demolitioned or rehabilitated under construction permits without occupying)
- 6. Copy of Fire Investigation report \$25.00
