

**MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL**  
**APRIL 16, 2018 COUNCIL CHAMBERS**

The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Monday, April 16, 2018 at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807.

Council President Rose read the following announcement:

Council President Rose led the audience in the Pledge of Allegiance.

**Minutes**

**MARCH 5, MARCH 19 AND APRIL 2, 2018- CLOSED SESSIONS**

The March 5, 2018, March 19, 2018 and April 2, 2018 closed session minutes were passed around for approval.

**Council Reports**

Councilman Kurdyla:

- Had nothing new to report. Regrets not being able to attend the opening days at Bridgewater Baseball and Bradley Gardens Little Loop.

Council Vice President Moench

- Attended Bradley Gardens Little Loop opening Day.
- Attended the Somerset County Governing Officials monthly meeting. The

topic of discussion was the opioid crisis. Mayor Perry from Hardwick Township whose son passed away from a drug overdose several years ago addressed this issue. A woman speaker who works for Somerset treatment services spoke about her experience in terms of treating folks suffering from opioid issues. She also spoke against legalized recreational marijuana and cited some of the main issues with same.

- Attended the meeting at Picatinny Arsenal who are in search of shared service opportunities. They are looking for organizations to use their facilities for things such as police training and fire arms qualifications.

#### Councilman Norgalis

- Attended the Bridgewater Baseball and Softball opening day. Tom Cannizzo, BBI President, advised that the Middle School baseball backstop had collapsed during a snow storm and the field is not available to them. Council President Rose researched this issue and indicated that the Board of Education insurance will cover this issue and repairs will probably be made in May. BBI attendance is up as teams from Branchburg, Readington and Manville have joined.
- Regarding the Planning Board, no word yet on when the Advance Realty (SANOFI) project will be resubmitted.
- Attended the Bradley Gardens Little Loop opening day. This was their 60th year of supporting the neighborhood youth. A plaque was given to long time local parish priest Father John Pringle who is retiring and who gave his last invocation.
- The biggest issue this week with residents is the uncollected storm damage material at the curbs.
- This week Councilman Norgalis will attend the 200 Club Annual Valor and Scholarship Awards luncheon on Wednesday and the Bridgewater Health Fair on Thursday at the Senior Center

**AN ORDINANCE AMENDING CHAPTER 126 ENTITLED "LAND USE," SECTION 126-2 SPECIFIC ACCESSORY USES" AND CHAPTER 125 ENTITLED "SWIMMING POOLS," TO REPEAL CHAPTER SECTION 126-194 ENTITLED "FENCES" AND TO CREATE A NEW CHAPTER 196 ENTITLED "FENCES AND RETAINING WALLS" TO CONSOLIDATE AND AMEND THE TOWNSHIP'S REQUIREMENTS RELATED TO CERTAIN PRIVACY FENCES**

Township Planner Doyle addressed questions previously received from the Council & fielded additional questions concerning the proposed ordinance.

Councilman Norgalis made motion to introduce the ordinance. There being no second to the motion, the Ordinance did not pass.

It was noted that Bridgewater Resident Mersinger who was the proponent that originally began discussions on the need for privacy fencing was present in the audience.

Comment**

On motion of Councilman Moench, seconded by Councilman Kurdyla, the meeting was opened to the public.

Members of the public wishing to address the Council will be allowed two minutes to speak, unless there are unusual circumstances.

Wesley Mersinger, 3 Hoagland Court was present. He expressed disappointment that the motion to approve this ordinance did not carry. As a tax payer, he opined he should be entitled to have privacy. He explained that having a smaller lot with a neighbor with an unsightly property and a drainage ditch that often is the cause of mosquitoes and bugs, he should be allowed flexibility in terms of installing privacy fencing.

Council President Rose indicated she would entertain a new motion to introduce the Fence Ordinance.

Comment**

Lawrence Powers, Esq. 14 Campbell Court in Bridgewater was present. He stated he is the president of the Friends of Bridgewater history and understands that no money has been budgeted for the preservation of the Lane Brokaw House. He expressed his understanding is that the Township received the gift of that property from the Fierro’s with the condition that the house must be maintained. He explained that this home has not been maintained and is currently uninhabitable. He expressed disappointment that this home, which he stated has been found to be the finest examples of a Dutch plantation house in the State of New Jersey is now in terrible disrepair. He explained the Friends of Bridgewater History are well able to raise some monies, which when combined with the County grant and Township match will be sufficient to repair the house. He requested that this home be maintained until the proper preservation efforts can be undertaken and offered there is a roofer who is willing to install

tarp on the roof while using his own insurance.

On motion of Councilman Norgalis, seconded by Councilman Moench, the public comment portion was closed

**PUBLIC HEARING FOR 2018 MUNICIPAL BUDGET  
BUDGET AMENDMENTS**

Councilman Moench stated Natasha Turchan, Director of Finance has prepared a budget amendment with changes as proposed by the budget subcommittee. On a macro level, Councilman Moench explained the numbers proposed to be spent are not changing. He discussed proposed amendments noting we are reallocating \$100,000, primarily towards debt reduction (this is approximately 1% of our total debt).

Township Administrator Naples stated they received the amendments later in the day and have not had an opportunity to review what the impact will be and therefore do not agree with the proposed amendments. He addressed some of the areas that have been reduced noting the new reduced numbers may not work although a thorough review of the amendments has not been conducted.

Councilman Pedroso stated the budget committee is confident the proposed numbers in the amendments are sustainable. He added the 1% debt reduction is better than no monies being allocated to debt reduction.

Councilman Kurdyla opined he trusts the judgment of the Township Administrator and Finance Director as to where the expenses should be allocated. He is more inclined to support the budget as proposed by administration He added that while it is commendable to allocate monies towards past debt, he cannot support it on a 42M budget.

Councilman Norgalis stated he is pleased with a 0% tax increase and supports the amendments.

Council President Rose was concerned that while the Township's needs continue to grow, our budget to support that does not continue to grow. She stated she did not like the 0% budget last year and does not like it now and opined it is short sighted and a mistake. With regard to historic preservation, she expressed disappointment that no monies were allocated to this item while we have acquired two properties that are of historic value to the Township. While she appreciates that some monies are being allocated to pay down debt, she believes the professionals put together a budget that they believe is in the best interest of the Township.

Councilman Pedroso opined there is a process to adopting the budget which entails the administration proposing a budget then Council goes through that budget then offers an opinion. He offered that approving the budget as proposed by administration is disregarding the process and is a violation of Council's obligation and duty to the public to review the budget. He also addressed the historical preservation noting there was a unanimous vote for monies towards the historic preservation and nothing was done. A quote that raised the monies for preservation is what caused a concern for the governing body. Councilman Pedroso offered he is willing to consider keeping holding off on adopting the amendment to the budget if Council President Rose would like to keep this discussion going.

Councilman Norgalis made a motion to approve the amendments to the budget. The motion was seconded by Councilman Moench and carried on the following roll call vote:

**RESOLUTION OF THE TOWNSHIP COUNCIL OF TOWNSHIP OF BRIDGEWATER OPPOSING THE LEGALIZATION OF RECREATIONAL CANNABIS USE IN THE STATE OF NEW JERSEY**

Councilman Moench stated this resolution is an important first step in sending a message as to where the governing body stands with regard to recreational cannabis in the community. This resolution states our stand is that we oppose it and have concerns over it and may move towards an actual ordinance to ban the sale or distribution of recreational cannabis within the town. He added that following the meeting at the Somerset County Governing Officials meeting, it affirmed his belief that Bridgewater should not allow recreational cannabis within its borders.

Councilman Norgalis made it clear our stand is against recreational, not medical marijuana.

Councilman Kurdyla offered he was of the impression that Council would hold off on taking any stand until the State is clear on their direction. Township Attorney Savo stated by adopting this resolution we are sending a message to the legislators how we feel about recreational marijuana.
