#### Discussion

#### NJ HUMANE LAW ENFORCEMENT ACT (\$3558)

Deputy Township Attorney Chris Corsini was present for this discussion. He stated that at the end of 2018, the State Legislature approved significant changes to animal control laws that abolished the New Jersey Society for the Prevention of Cruelty to Animals and vested that entity's enforcement responsibility related to animal control to municipalities and counties. Under this law, the governing body of a municipality must select at least one applicant for designation as a Municipal Humane Law Enforcement Officer (HLEO) who shall be responsible for animal welfare within the jurisdiction of the municipality.

Following an extensive discussion, Council was in consensus that in the interim & as we await the County's decision/direction regarding this matter, Brian Bradshaw, the current manager of our animal shelter will be named the animal control investigator. The Township Attorney will prepare a resolution to reflect this decision and provide to Council at a future meeting for review & approval.

#### HISTORIC PRESERVATION COMMITTEE

Councilman Pedroso discussed the possibility of establishing a historical preservation committee in order for Bridgewater to preserve its history and so that residents can have a place to donate historical artifacts. This includes documents, photographs, videos, statements, recordings of people that have lived in the Township for a long time etc.

Councilman Pedroso proposed a 7-person committee of volunteers. This committee is not for the purposes of purchasing historical property but rather organizing and preserving historical documents and perhaps organizing educational programs about Bridgewater for our residents. Councilman Pedroso stated it will be good for the residents to have a place where they can trust that if they want to donate a historical artifact that has been in their family for

years, they can leave it with the Township where it will be preserved and it can be stored for the future.

Council President Rose offered being there are other historical committees, there has to be clarity about the expectations for this proposed group so that it doesn't conflict with other groups that although not doing the same work are very similar.

It was mentioned that the historical committees referenced by Council President Rose where Ad-Hoc in nature and not appointed by the Council or Administration.

Council was in consensus to allow the drafting of a resolution to form a historical preservation committee, appointed by the Council that is focused primarily on preservation of historical artifacts. Said resolution will be presented to the Council for action at a future date.

#### Public Comment

On motion of Councilman Moench, seconded by Councilman Kurdyla, the meeting was opened to the public.

Members of the public wishing to address the Council will be allowed two minutes to speak, unless there are unusual circumstances.

Wesley Mersinger, 3 Hoagland Court was present. He addressed the Council concerning the ordinance regarding privacy fences. He spoke in favor of same stating it will provide an upgrade to his home and privacy for his family so that he is not surrounded by an overgrown drainage ditch and doesn't have to look at neighboring properties which are in disrepair. He pleaded that Council vote affirmatively on this Ordinance.

Amy Whitney, 529 East Main Street was present. She also addressed Council concerning the ordinance on privacy fences and spoke in favor of same. Ms. Whitney stated privacy fencing will allow her to enjoy her backyard and asked that Council vote affirmatively.

On motion of Councilman Moench, seconded by Councilman Norgalis, the meeting was opened to the public.

James Russo, 116 Hillside Avenue was present. He spoke in favor of this Ordinance stating a privacy fence would allow him shielding from headlights and provide him more options in terms of what types of fence he can erect.

On motion of Councilman Norgalis, seconded by Councilman Kurdyla, the public comment portion was closed.

Councilman Pedroso stated he has lived in 8-different addresses in Bridgewater Township including condos, townhouses, apartments and single family homes. He added that by approving this ordinance, we will essentially change the

character of this Township. Although sympathetic to the needs stated by the residents that have addressed Council, he stated he is unable to support this proposal noting the residents are not without recourse as they can go before the Board of Adjustment to obtain approval for privacy fences. Councilman Pedroso recommended the Township put together a cheaper and more expeditious process for fence applications. He also suggested a study of areas within the Township that are in need of fences rather than pass a township wide law change.

Councilman Moench stated that although he agreed there needs to be changes to the current fence ordinance, the proposed ordinance is too broad. He offered privacy fencing should be looked at per zone or allowed only is certain situations.

Councilman Kurdyla offered that the governing body should pass this ordinance as is in order to alleviate the concerns stated by residents. A second phase to study those areas in need of privacy fences should then ensue and a second ordinance should then be prepared.

Scarlett Doyle, Township Planner was present to field questions from the governing body. She stated that surrounding towns support solid fencing along property lines as has been proposed in this ordinance. She further explained the Planning Board has stated they do not wish to distinguish zones and prefer for the fence ordinance to be universal throughout the township.

Township Administrator Naples stated this will allow for the continuation of our road improvement project which we have been aggressive in funding.

Councilman Moench questioned how roads proposed to be improved were selected. Township Administrator Naples explained the Township Engineer recommended the roads for improvement. He utilized the road improvement study done last year by the Ad-Hoc committee. There was then a separate citizens committee which looked at those recommendations and agreed to same. Councilman Moench asked for a copy of the report as well as any other scoring documents used as a basis for selecting the roads.

Councilman Moench stated there is a 20-year useful life for bond ordinances and questioned whether there has been an independent evaluation of these roads to determine whether or not they are expected to last 20-years. Township Administrator Naples stated they believe the roads will last 20-years. The only roads that have not lasted that length of time include Crim Road and Milltown Road as the State had required us to use a superpave mix. This is no longer a requirement and therefore the roads should last 20-years or longer.

Councilman Moench stated when Council approved the budget this year, additional monies were allocated for down payment of bonds. In that regard, he stated he would like to ascertain this is being done.

Councilman Kurdyla stated that concerning Adamsville Road, no work should be performed until the weight limit issue is straightened out. Currently, there are a lot of tractor trailers that grossly exceed the weight limit and are destroying this road.
