• Handed in a bill from NJ Nurseries to Joe as requested last month.

- Command vehicle needs brakes and new driver's side window motor. The fire department owns the window motor and this will be given to the mechanic when the brakes are done to get the window repaired as well.
- Hydraulic ram has not been working. It will open but not close fully. The board will check with
  the chief to see if he would like to get ESI Equipment, who has serviced our tools in the past, to
  come service all tools including ram repair.

### Rescue Squad Chief's Report: Yes

- Report handed in for the month of April.
- Command vehicle went in for service. Mechanic had to order some parts for the front end and the vehicle will go back to the shop once parts are in.

#### **Old Business:**

- LOSAP payment has been made for 2017 and our LOSAP logs for the members have been updated.
- Reimbursement program update: Connor Tereman still cannot be reached regarding his check for \$75 from 2017. We will hold it for another month to see if the assistant chief can reach him.
- Firehouse approved the lighting on the front of the bays. North Branch Electric was notified and will complete the work before the end of 2018. The board will send them a copy of our tax exempt certificate and North Branch Electric will supply the board with proof of insurance.
- We will visit First Priority Emergency Vehicles to look at chief vehicles. This is to the give board
  an idea on what a new vehicle will cost when the time comes to replace our current command
  vehicle. The rep will call us in the coming weeks they are currently in the process of finishing 3
  vehicles and would like us to come see their finished product.

 The board discussed the possibility of having the fire chief hand in all LOSAP paperwork for the prior month at each of our meetings. The board will handle totaling categories and posting LOSAP updates on our door. All were in favor.
