#### Meeting Minutes of the May 8, 2018 BOFC District #1 Meeting

Mr. Kalfsky motioned and Mrs. Zampella seconded that Mr. Rose be authorized to pay the full payment \$174,986.00 for the rig when the rig is completed as per the Martinsville Rescue specs. He will deal directly with Mr. Vicary on payment.

Chief Manna also advised the second session of an 8 hour long CEVO is being completed tomorrow as per a request by the BOFC for drivers of the new rig.

Mr. Rose provided the lease to Chief Manna to sign and date after the meeting.

Chief Manna provided the Rig usage stats.

#### **Insurance and LOSAP:**

**Insurance:** Mrs. Zampella reported that we received a notice that the life insurance was due to cancel for nonpay. We did not receive the last bill. Mrs. Zampella calling Harleysville to get a bill. Mr. Rose advised we need to check the bill to be sure it is accurate and the proper members are listed on the bill. <u>New Fleet Apparatus:</u> Chief advised the truck came in Friday evening and the specs. Mr. Rose advised that the missing divider was addressed with company. Full payment will be contingent on verification of that divider. Mrs. Zampella motioned and Mr. Rosenberg seconded that Mr. Rose have approval to pay the final bill once the Fire Department verifies that everything is in as ordered.

**Disposition of Engine 2:** Mr. Rose advised that he and the Chief are going through all the previous repair bills and the financial reports that Engine 2 has had. The reports show that Engine 2 costs twice as much in maintenance and repairs as Engine 1 which is older. They will finish putting together a report to have for the record.

**Engine 4 Motor Oil Leak**: Cat rebuild estimates were discussed. Mr. Koerner advised the options are to take it apart to see if there is a cracked liner. Cost would be approximately \$10K. Would cost the same to have a rebuilt engine. Everyone agreed with the suggestion to run it and keep and eye on it.
