Thank you for inquiring about affordable housing with Bridgewater Township. We currently administer over 600 rental and purchase units of Affordable Housing throughout Bridgewater Township. However, we receive a greater number of applications than there are units available, so placement in a unit is often not immediate.

In order to be eligible for an affordable housing unit, you must meet certain income limits as determined by the New Jersey Council on Affordable Housing. Income limits are determined by region. Our housing units are located in Region 3, which includes the following counties: Somerset, Hunterdon and Middlesex Counties. Income limits can vary from year to year and depend upon the number of persons in the household. The income limits for 2018 are:
