#### Discussion

Thomas Branch conducted the presentation. He stated that he is the Vice President of Stavola Construction Materials who are the owners/operators of the Stavola Quarry located along Route 22 on Chimney Rock Rd. Per Township Ordinances regarding Quarry manning, Stavola is required to submit a renewal application every year in order to continue their business and as such, an application was filed with Chip Mills, PE of the Engineering Department. The application requests the exact same license that was requested the previous year.

Mr. Branch discussed the 2014 mine plan and provided a document regarding same which demonstrates the overall outline of the quarry, the active areas currently being worked on, existing stormwater basins, areas that have been reclaimed for development, County facilities, areas that are proposed for future redevelopment and areas that are available for future mining activities.
