MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL November 7, 2013 COUNCIL CHAMBERS

Council Reports

Councilman Norgalis reported he completed the school visits for the fire departments and attended an information session to discuss the proposed solutions for impounds 1 and 2 which are the worst of the areas in the Cyanamid Site. He also attended the Halloween festival and took part in an election. Councilman Norgalis congratulated Councilman Kurdyla and Pedroso on the election win. She spoke in opposition to having 24/7 operations/businesses within 200-ft of residential properties noting that Bridgewater residents expect a certain level of quality of life that will be impacted by traffic, lighting, noise, etc if such operations were allowed. She asked that Council consider putting an Ordinance in place that would restrict/prohibit 24/7 businesses.
