## Division of Tax Collection

### Frequently Asked Questions

**Q: How do I make an online payment?**

A: Go to [www.bridgewaternj.gov](http://www.bridgewaternj.gov), click on “Pay Property Tax Online” or “Pay Sewer Utility Online” and follow the prompts.

**Q: Can I use my bank’s online banking portal to submit a payment?**

A: Yes, you can!

If payment is made through your online bill pay, please create 2 payees for Bridgewater Township.

- **Bridgewater Twp Tax** should have your **tax account number** in the account field. Do not use your Block and Lot.  
This is an eight-digit number that can be found on the upper left corner of your tax bill.
- **Bridgewater Twp Sewer** should have your **sewer account number** in the account field. Please make sure you include the hyphen when setting up this type of payment. Do not use your Block and Lot.  
The sewer account number is printed on the upper left corner of your sewer bill.

**Q: What other payment options are available?**

*One check per tax or sewer account. Payment stubs **MUST** be included.*

Tax Office Hours are M-F 9:00 a.m. to 5:00 p.m.

**Q: When are taxes due?**

Taxes are due on the first day of February, May, August and November.

**Q: When are sewer bills mailed?**

A: Sewer bills are mailed at the end of January.

**Q: When is sewer due?**

A: Sewer is due on March 1 and September 1.

**Q: How can I obtain a copy of my tax or sewer bill?**

A: A copy of your current tax bill and sewer bill is available on our website. To access the pdf file, start at our homepage, click on "Pay Property Tax Online" or "Pay Sewer Utility Online" and follow the prompts.

**Q: What is an Added/Omitted bill?**

A: If improvements to the property have been completed prior of October 1 of the tax year, a separate tax bill for added/omitted will be issued and mailed in October. Added/omitted bills are due on Nov. 1.

**Q: How do I request a change to the billing address for my property tax and sewer utility bill?**

A: Changes to the billing address can be submitted to [taxassessor@bridgewaternj.gov](mailto:taxassessor@bridgewaternj.gov). If you have any questions, please call 908-725-6300 ext. 5121.

**Q: I would like to redeem a Tax Sale Lien. How do I obtain a lien redemption calculation?**

A: Please send an e-mail to [taxcollector@bridgewaternj.gov](mailto:taxcollector@bridgewaternj.gov). The e-mail should have the property information and the date a certified check will be delivered at the tax collector's office. No verbal redemptions are given over the phone.

**Q: I paid off my mortgage. What now?**

A: Notify the Tax Collector's Office by sending an e-mail to [taxcollector@bridgewaternj.gov](mailto:taxcollector@bridgewaternj.gov). Contact your lender to confirm the last payment that will be made or was made on your behalf and make the next payment.
