### Frequently Asked Questions

**Q: Where is the Recreation Office located?**

A: 100 Commons Way, inside the Municipal Building, first floor. Office hours are Monday through Friday 9:00 a.m. to 5:00 p.m. You can reach us at (908) 725-6373 or [recreation@bridgewaternj.gov](mailto:recreation@bridgewaternj.gov).

**Q: Who can participate in our programs?**

A: Most programs are open to all Bridgewater residents. If space allows - residents of other towns such as Raritan may participate in some of our programs for an additional fee of \$25.00.

**Q: How do I register for a program?**

A: Registration can be completed online at <https://brd.leagueapps.com/camps> or in person at our office.

**Q: When does registration open?**

A: Registration dates vary by program. Please check our website for the most up-to-date schedule.

**Q: Do you have programs for seniors?**

A: Please contact the Bridgewater Township Senior Center at (908) 725-8020.

**Q: Can I rent park facilities or fields?**

A: Fields are available via permit application. Our parks, including Kid Street, are open to the public, first come first served. For all fields except Flannery Field (Municipal Complex Turf) an e-mail must be sent to [recreation@bridgewaternj.gov](mailto:recreation@bridgewaternj.gov) at least one month prior to the start of the season with a request for fields. The email must include the requested facility, dates & times of use, and the start/end date of the season.

For Flannery Field (MCT), inquiries can be submitted at <http://brd.leagueapps.com/even...> If a permit is issued, the fees for this field are \$140 per two hour time block without lights, and \$220 per two hour time block with lights.

**Q: Are dogs allowed in the parks?**

A: Dogs are welcome in designated areas, but they must be always leashed. Please clean up after your pet. No dogs are allowed on Turf facilities.

**Q: Does Bridgewater Township have Pickleball Courts?**

A: The Pickleball Courts in Bridgewater are owned and operated by the Somerset County Park Commission. They can be reached at (908)722-1200.

**Q: What is your refund policy?**

A: All refunds issued will be charged a \$10.00 administrative fee except for refunds issued due to a program cancellation. One administrative fee will be charged per family, if requested at the same time. Refunds will not be issued for travel sports. We reserve the right to cancel, alter, supplement, limit registration or change any dates, times, locations, ages, and fees.

No refunds will be issued after the program registration deadline. If there is no deadline, no refunds will be issued on or after the day of the first class, evaluation, or practice. No refunds will be issued if a program does not run its full course due to inclement weather, gym cancellations or circumstances beyond our control.

**Q: Where can I find weather cancellations/updates?**

A: We will post inclement weather decisions on both the code-a-phone system (908) 526-7107 and website [www.bridgewaternj.gov](http://www.bridgewaternj.gov). Field closings are posted by 3:30 p.m. weekdays and by 7:30 a.m. on weekends. If nothing is posted by those times, please report to your designated field for a coach/umpire/referee decision. If Bridgewater-Raritan Public Schools are closed due to inclement weather, all Bridgewater Recreation activities/programs will also be cancelled.

**Q: Do you have volunteer opportunities?**

A: Absolutely! We welcome volunteers for youth coaching, events, and community projects.
