Lead inspector/risk assessor and community noise enforcement certifications preferred.

#### **Experience:**

One (1) year of experience in performing the duties incumbent upon a Registered Environmental Health Specialist in the enforcement of relevant sanitary, environmental, and public health laws and rules.

#### SUPPLEMENTAL INFORMATION
