CHIEFS REPORT

CHIEF ENGINEERS REPORT

The department is beginning to resume some operations within the guidelines established by the amended Executive Order. Work details are resuming following social distancing practices. Drills will be conducted following appropriate practices. Response to calls for service will follow established protocol that preceded the pandemic. These changes will be monitored as the Covid situation evolves. Weekly reporting to the Division of Fire Safety seems to have ceased at this point.

All the apparatus including the rescue squad has been updated to utilize the county fuel system. Each apparatus now has two keys to complete the fueling process. Apparently at the change of title with the ambulances the proper registrations were never completed. This has been corrected. All the district equipment has also been bar coded to comply with an upgrade the county will be completing for fuel services. Currently only the Hillsborough facility utilizes the bar code system. I have also forwarded to the Chairman and Commissioner Ranallo the fuel certification certificate from the distributor of the diesel fuel for the county showing the fuel meets the low sulfur requirements. It will be up to the Board if after the Speedway project is completed where the apparatus will be fueled.

All the apparatus has been detailed except for the actual ladder device on Tower 30. This will be completed on Thursday or Friday weather permitting. The reason for the delay is the ladder rails must being greased immediately after the work is completed along with applying silicone spray on the wire cables, pulleys, and the water way. I believe it is in the best interest of the district to have all the apparatus professionally detailed once a year to protect the investment and to case the burden on the volunteers. I request Engine 302 be detailed in the fall prior to the winter months. Tower 30's aerial testing with non-destructive magnetic testing was also completed with no reported issues.

The final report on hose testing has been received. A total of 470 feet of hose has failed. The majority of failures appears to be coupling leakage. The company that services our extrication equipment also is the company that repairs our hose. Once they are scheduled it will be determined if the hose can be repaired or replacement on some of it will be requested.

Annual fire extinguisher service and certification has been completed and air pack flow test certification will commence on July 1, 2020.

Three gas detectors will have their semi-annual calibration completed.

The nozzles for the standardization project on Engines 301/303 and Tower 30 are in the process of completion. The nozzles have been ordered and delivery is pending.

Lam presently working on recommendations to the Board regarding the Incentive Program for the department. I will have them completed by the July meeting.

Discussion on how the Rescue replacement project is going to proceed.

Deputy Chief Command Vehicle Proposal

This proposal is being presented in an attempt to look into the purchase of a Deputy Chief Command Vehicle. This Command Vehicle would be utilized to supplement Car 30. Below is a short list of reasons a second Command Vehicle will be beneficially to the operation of the fire department and the safety of the public.

- Safety on scene due to sufficient emergency warning lights specifically when operating in the roadway.
- Is essential at Incidents requiring a Command Post when Car 30 isn't on scene. Having two Command Vehicles betters the chance of a sufficient Command Post being established.
- Carries essential equipment that a personal vehicle cannot, such as a fire extinguisher, bolt cutters, irons, preplans, emergency contact information, etc.
- Can be used to transport addition firefighters to the scene or swap out firefighters during a
 prolonged incident.
- Allows a Chief Officer to arrive on scene quicker to assess the incident and provide immediate emergency assistance.
- Provides a Command Vehicle in Finderne when Car 30 is on a mutual aid assignment.

Currently, we have an opportunity to purchase a 2001 Dodge Durango from East Franklin Fire Department. The vehicle is equipped with lights and siren for the price of \$1,500. If a decision is made to move forward with the need of an additional Command Vehicle, I would like to have a workshop meeting to discuss the purchase in further detail (Lettering, maintenance, radio install) and a full presentation on the Command Vehicle will be presented at the next board meeting.

We recently received a \$4,083.93 check from AirGas for a Haz-Mat incident in December of 2019. If this money is available, I believe this project could be completed using these funds.
