The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Monday, April 19, 2021 at 7:30 p.m. via electronic communication.

Minutes

APRIL 5, 2021 - REGULAR SESSION

On motion of Councilman Norgalis, seconded by Councilman Kirsh, the March 18, 2021 regular session minutes were moved for approval and passed unanimously on a voice call vote.

Council Reports

Councilman Kirsh

- He discussed the applications that the Planning Board heard recently. One was a reforestation plan off Route 287 near TD Bank Ball Park. There is an area that is in disrepair and over time there has been a lot of significant disease to the tree buffer. This is a plan that needed Planning Board

approval as well as approvals from various other State agencies. The second case was the Verizon Wireless was authorized to go back to the PSE&G tower in the Milltown neighborhood subject to some conditions of approvals that they have to comply with.

- He along with the recreational department and representatives from Bridgewater soccer will be partnering to collect food during the month of May and will then have that food donated to the Food Bank network of Somerset County. More information will be provided at the next meeting.
- Participated in the Bradley Gardens Little Loop events.
- The Fire Districts election will be taking place in person tomorrow from 2pm to 9pm.

Councilman Norgalis:

- Another sad passing. This time Tom Marshall, only recently retired from township service, has died. Tom will be remembered by all who worked at the municipal building as the “go to” guy to get things done.
- Allen Kurdyla and I sponsored a Fire Safety article that was published in the township newsletter. I hope our residents take that information to heart.
- Our friends of the MUSLIM faith began the holy month of RAMADAN which goes from April 13 to May 12. This special time includes several spiritual requirements including fasting. Ramadan is a time of spiritual reflection, self-improvement, and heightened devotion and worship. Muslims believe that Ramadan teaches them to practice self-discipline, self-control, sacrifice, and empathy for those who are less fortunate, thus encouraging actions of generosity and compulsory charity.
- I participated in the Somerset County LGBTQ+ ‘Law Night’: virtual meeting last week. Eight of New Jersey’s Attorneys Spoke about issues affecting the LGBTQ+ Community. - I attended the breakout session dealing with Law. There were others dealing with Estate Planning, Adoption and Discrimination. The meeting helped me to better understand the concerns and issues faced by people who identify themselves with one or more of these categories.

- Attended, along with Council President Pedroso the 1:30pm Bradley Gardens Little Loop Baseball season start. A sure sign we are slowly getting back to a semblance of normalcy.

Councilman Ring:

- According to some media coverage, the Local Institute of Local Government Attorneys have taken a similar position as the NJ League of Municipalities and are encouraging municipalities to ban cannabis in their towns until the State cannabis regulatory commission figures out next steps.
- Played the role of Closer on Saturday at the Bradley Gardens Little Loop.
- Attended the viewing of our long time township employee, Thomas Marshall who also was a longtime volunteer firefighter and at one time led the operations at the Finderne Rescue Squad. He will be missed.
- County guidelines stipulate that the ballot dropboxes in each of the towns, including the one at our town hall cannot be used to receive fire districts' elections mail in ballots. Residents are encouraged to drop off the ballots at their polling locations.

BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$8,000,000 FOR VARIOUS ROAD IMPROVEMENTS, INCLUDING BUT NOT LIMITED TO FIELD STREET, WOODROW AVENUE, POPLAR STREET, RED LION WAY, ST. GEORGES ROAD, CAMBRIDGE LANE, MALLARD DRIVE, MASTAPETER ROAD, AMUR ROAD, AND REDWOOD ROAD, INCLUDING CURBING, MILLING, PAVING, DRAINAGE, SEWER AND OTHER MISCELLANEOUS IMPROVEMENTS AND VARIOUS ROAD OVERLAYS THROUGHOUT THE TOWNSHIP IN AND BY THE TOWNSHIP OF BRIDGEWATER, IN THE COUNTY OF SOMERSET, NEW JERSEY AND AUTHORIZING THE ISSUANCE OF \$7,600,000 BONDS OR NOTES OF THE TOWNSHIP FOR FINANCING PART OF THE APPROPRIATION

Mayor Moench stated this Ordinance is for an investment to our road infrastructure. The roads being considered are listed on ourbwroads.com. He added we hope that by going out to bid earlier, prices may be competitive and we may be able to tackle additional roads.

William Burr, Township Engineer provided an overview of the projects completed in 2020 roads and some of the roads that continue to be in the works. He also discussed the 2021 roads noting we contracted an outside consultant to Review Township owned roads. As a result of that it was determined what roads to tackle and in what order. In total, 150-roads out of 275 roads will be improved in the next five (5) years which equates to most of the bad roads. He added that after the 5-years, we will be able to maintain township roads more effectively.

Council expressed their support and appreciation to the Mayor for his work, initiative and vision for tackling Bridgewater Roads noting this is a project that will benefit our township for many years to come.

Mayor Moench acknowledged Michael Pappas, Township Administrator, Thomas Genova, Director of Municipal Services and William Burr, Township Engineer for their work on this project. He also thanked Council for their support throughout this process.
