On motion of Councilman Norgalis, seconded by Councilman Ring, the July 8th and July 19, 2021, regular session minutes were moved for approval and passed unanimously on a voice call vote.

Council Reports

Councilman Kirsh

- On August 5, attended together with Mayor Moench the Chase's Chairs Event at the library. He noted Megan and Justin Muncheon suffered the loss of a premature child and to raise awareness and in the baby's honor sponsored a program in which Somerset County donated Rocking Chairs to 10 Libraries throughout the County.
- He visited the Mini Library at Kid Street Park presented by the Girl Scouts.
- He attended together with Councilman Pedroso and Councilman Norgalis the Relay for Life Event at Duke Island Park.
- On August 7th, he together with Councilman Ring attended the Mobile Justice Initiative in partnership with the Macedonia Baptist Church in Hobbstown where two vehicles were retro fitted; one as a soup kitchen and the second a computer access lab to deliver services to others. He reported he was honored to speak at this event and was proud to share in a community spirit banning together for others.
- He attended together with the rest of the Council members and Mayor Moench the sendoff for 14u Bridgewater Panthers as they were headed to the 2021 Babe Ruth World Series in Iowa.
- He attended the Celebration of Life for Lieutenant Colonel Robert Vaucher on Saturday, August 14th which he noted was broadly supported by all.
- He reported the Census numbers in Bridgewater rose to 45,977 which was a 3.4% increase and 6.8% increase County wide.

 Met with Tom Genova on site to review paving/resealing in neighborhoods and offered this method adds a dramatic increase in the useful life of the roads.

- Timing is everything. The Council approval of the resolution to purchase and install a new pump for the Gilbride Sewerage Pumping Station a few weeks ago was fortunate. One of the other three pumps has failed and tonight we will have the opportunity to purchase an additional pump using virtually the same resolution as last month.
- The Steeplechase road work, which was done with State Grant Support, has been completed in time for school opening. This will be especially pleasing to school bus drivers handling Eisenhower School who will note both entrance and exit township streets have also been repaved.
- The completion of the sewer work on Old Farm Rd. is tentatively scheduled for the week of Thanksgiving. The street will be entirely repayed as part of this project.
- Attended the Relay for Life at Duke Island Park in support of the American Cancer Society.

• Attended the 14 and under Bridgewater boy's baseball team send off as they headed to lowa via bus for national competition. It was a 16hour bus ride.

Councilman Kurdyla:

- Reported he drove his eldest daughter to college this past weekend and in doing so was not available to attend the Celebration of Life in honor of Bob Vaucher but he did create a video in his honor and expressed he wished he could have ben there in person.

Mayor's Reports

Michael Pappas, Administrator

Mike Pappas on behalf of the Mayor Moench reported a special meeting will be held by Council on Monday, August 23rd, to complete the awards for the 2021 road improvement plan and requested to add a resolution from finance to extend the grace period for the 3rd quarter tax period from August 1 to October 6, 2021.

2021Road Improvement Plan Update

Mr. Pappas stated Bill Burr, Township Engineer and Tom Genova, Director of Municipal Services were present to provide an update on the 2021 Road improvement Plan to date.

Bill Burr, Township Engineer presented Council an update on the BWT-21-7 - Efficient, Deliberate & Prudent Road Selection in 2021. Bill detailed the

selection process done by Universal Road Assessment through a calculated system grading roadway 1-5; 5 being the worse. He added because of that data they were able to put together like areas and grouped the road improvement projects 2021-1 through 2021-7 representing its own section of town.

Most of the projects have already been awarded but during the special meeting on August 23rd, engineering would like to present 2021-2 and 2021-7. Bill noted roadway status is available for residents to check on line.

Bill prepared mapping and distributed to Council the current data for each of the top 50 roads and presented in percentage of mileage reconstructed over time up to 2023 & 2024. Each project is making great progress but noted there is much more progress to be made this season.

Bill noted with bidding coming in under budget, its anticipated there will be additional money available to maintain another grouping of roadways that although were not the highest on the list for improvement, the cost savings from bidding will afford the maintenance and greatly extend the life of these roadways up to twelve years.

Councilman Norgalis complimented Bill for the in-depth summary.

Councilman Kirsh relayed he interacted with a resident and was pleased to afford the resident the availability of checking roadway progress online.

Bill Burr offered the resolution on the agenda for the 2022 Municipal Aid Grant will hopefully be submitted and approved by NJDOT to offer up to \$750,000 for the Rolling Hills Road and sanitary improvements.

Proclamation Hobbstown

Mike Pappas read the Hobbstown proclamation in honor of the 100th Anniversary of its Founding Celebration as follows:

WHEREAS, in the year 1920, Amos Hobbs first purchased land off of what is today North Bridge Street in Bridgewater Township, thereby beginning a legacy which is today priceless not only to the families of Hobbstown but to the entire Bridgewater community; and

WHEREAS, in the years following, Amos moved from Brooklyn to Bridgewater alongside his brothers General Washington and Robert Hobbs, all of whom later invited other family members and friends from Georgia to join them in the new place they would call home; and

WHEREAS, this community of families formed the core of what we know today as Hobbstown, which has stood, endured, and thrived in Bridgewater through the past hundred years; and

WHEREAS, successive generations of Hobbstown families and residents have witnessed and lived

through a century's worth of seminal and transformative events, movements and moments of American history; and

WHEREAS, many of these have moved us ever closer toward the fulfillment of the Founder's promise, and the realization of Martin Luther King Jr.'s dream; and

WHEREAS, in the years, decades and generations since its founding, Hobbstown has become an integral part not just of the social fabric of our community, but of Bridgewater Township's living history; and

WHEREAS, the residents of Hobbstown have made and continue to make invaluable contributions toward the welfare and betterment of the entire Township, County, State and Country, most particularly to the benefit of Bridgewater Township itself; and

WHEREAS, so that all Bridgewater residents can join together in the celebration of the Hobbstown Centennial, the Township government has directed the installation of flags on Monmouth Avenue and North Bridge Street which recognize the Bryant, Hicks, Hobbs, Miller, Murdock, Proctor, Sermons, McCray and Tukes families for the decades during which they've acted as the very foundation Hobbstown and as a pillar of Bridgewater Township; and

WHEREAS, all citizens of Bridgewater and their elected and appointed representatives are immensely proud and grateful to have Hobbstown, its generations of residents and its legacy as a treasured part of their community;

NOW THEREFORE BE IT RESOLVED THAT, I, Matthew C. Moench, and the members of the Bridgewater Township Council, on behalf of the citizens and government of Bridgewater Township, do hereby warmly congratulate the residents of Hobbstown on the Centennial of its founding, recognize the indelible mark generations of Hobbstown residents have left upon our community for the better, express our immense pride that Hobbstown has for so long been an integral part of our living history, and declare our everlasting support for Hobbstown residents, their community and our common legacy. To the next hundred years!

Council President Pedroso noted another one of Bob Vaucher's achievement's is represented in Hobbstown, as he was instrumental in negotiating with the State Department of Transportation to reroute the 287 Interstate to avoid tracking through the Hobbstown properties.

Thanked the Governing Body and Administration for the Bridgewater Panther Baseball World Series sendoff fanfare.

Acknowledged Councilmen Kirsh and Kurdyla for attending the Women's Veteran Appreciation Day

Requested consideration be given for safety concerns on Washington Valley/Crim Intersection and other roadways where site has been impaired by Amazon, Fed Ex and landscapers parking along the roadway noting these are a danger to children, walkers and oncoming vehicles.

She added it is nice to hear about Bob Vaucher and his many achievements and accomplishments but does not support the resolution at this time and opined it's more important to focus on the citizens at this time until things normalize.

Donna Lazarik, 254 Altamont Place, Somerville, NJ 08876

Thanked all that attended the Celebration of Life Celebration for Bob Vaucher last weekend. She offered he was a humble person but he did appreciate the recognitions throughout his life. She played a voicemail audio from her phone were Bob was speaking on various topics so all could hear as he expressed his words and thoughts.

Ms. Lazarik stated she understood the tabling of the resolution but noted for all in attendance to watch the video prepared by Council President Pedroso who expressed support for Bob and his legacy and the hope to embrace and capture this man's accomplishments in the history of the Township for future generations. She expressed she and the Vaucher family stand ready to support the decision.

Evonne Vaucher, California

Thanked Council for their efforts in honoring her father and appreciated the story on the construction of Interstate 287 that Council President Pedroso relayed earlier and also for the beautiful video he prepared to honor her father.

Kathy Franco, 766 Weemac Road, Bridgewater, NJ 08807

Stated she came to address the resolution in honor of Lieutenant Col. Bob Vaucher. She stated she wholeheartedly appreciates those who give to the community and those who have served. She acknowledged Jim Dowden former Mayor for his achievements and others including, Steve Kalafer, Philanthropist and community leader, Robert Forsythe who volunteered his time and service to the community for years in the Fire Department, Howard Bixler, EMT & Rescue member and his many accomplishments, George Scofield, Naval Service Township Businessman 15-year volunteer for the Martinsville Rescue Squad driving and serving through his mid-eighties.

She stated the Municipal Complex is a "Citizens Building" not to named after

one person and urged Council be careful choosing a naming of just one.
