- Tower 30 is back in service. The front speaker covers were replaced along the radiator. The trucks preventative maintenance was also completed. Tower 30 is scheduled for its annual detailing in October.
- Engine 302 has its axles drained from the flood waters. Engine 302 also had it preventative maintenance completed. It was detailed in preparation for the township inspection.
- Engine 303 is currently at Fire & Safety getting its rear axle drained from the flood. Hoping the annual preventative maintenance will also be completed.
- The fabricator will give us an estimate to mount the rescue tools in the rear transverse compartment in anticipation of the sale of Rescue 30.
- Rescue 30 is back from Stewart & Stevenson and back in service.
- Engine 301 suffered no flood damage and is waiting for its annual preventative maintenance.
- Deputy Chief's vehicle was serviced on September 23, 2021. No issues were found.
- Deputy Chief Marshall will be arranging familiarization training on the Halmatro hydraulic tools and Paratech struts hopefully before our formal

training on October 23, 2021. He will also be rescheduling the live burn, Somerville Tower sustained damage from the flood.
