Resolutions

AUTHORIZING THE EXECUTION OF DOCUMENTS NECESSARY TO ENTER INTO THE NATIONWIDE SETTLEMENTS TO RESOLVE ALL OPIOID LITIGATION BROUGHT BY THE STATES AND LOCAL POLITICAL SUBDIVISIONS AGAINST DISTRIBUTORS MCKESSON, CARDINAL HEALTH, AND AMERISOURCE BERGEN AND MANUFACTURER JANSSEN PHARMACEUTICALS AND ITS PARENT COMPANY, JOHNSON & JOHNSON

Alex Fisher, Deputy Township Attorney provided a summary of this resolution noting that this has to do with a nationwide litigation against two distributors; McKesson, Cardinal Health, and Amerisource Bergen and one manufacturer; Janssen Pharmaceuticals. There is a \$26 billion settlement that is to be distributed amongst thousands of Municipalities and States with the final exact number to be determined based on the impact of the opioid crisis and the population of each local municipality. Bridgewater's share is 0.0018%. Theoretically, it could be over a million dollars for use towards the opioid's crisis. The final number will be devised by the State of NJ however, the more municipalities and states opt in, the more the pot of money grows.

The Attorney General has recommended that all municipalities authorize their administration to opt in which is the purpose of this resolution. The opt in must be done by January 2, 2022 which is why this is time sensitive.
