MINUTES OF REGULAR MEETING December 15, 2021

CHIEFS REPORT:

44 calls, 600 Man Hours - Report attached

- All Milwaukee equipment has been received.
- Captain Fernandez is working on completing the Man in the Machine kit.
- Steve Neiderle is putting shelves in the Ramsey Street Bay to store the equipment for Rescue 30.
- SCOTT masks and the CAFS, are still pending.
- Chief Jannone has forwarded the signed receipt of the list of equipment on loan to Somerville Fire Department.
- Utility 30 graphics are complete. The emergency lighting and equipment has been ordered.
- Car 30's thermal imaging camera charger should be installed by the end of next week. The original charger malfunctioned and shorted out.
- Engine 301 was damaged on Saturday while participating in a fire department function. Damage was to the passenger's side rear of the vehicle. The parts include the exhaust pipe, rear chrome fender skirt, two lower chrome trim pieces and the rear compartment door lock release and handle. The damage doesn't seem to need require service from the body shop.
- Engine 302 and Tower 30 both have new intake valves on their pumps.
- Engine 303 has had two more Halmatro rams installed in the back compartment. The battery charger on the truck is malfunctioning and should only be plugged in intermittently. A new battery charger and foam level gauge have been ordered, both repairs should be completed by the end of the month.
- Tower 30 is once again experiencing issues with a radiator leak. Chief Jannone has spoken with Fire & Safety and that our truck and a truck from Cranford as experiencing the same issue. The repair is being done at no charge to the district. The truck is likely to be out of service for a minimum of three weeks.
- Chief Jannone would like to recognize the members that responded to the fatal fire in Somerville last Friday. The outcome was devastating but our members showed resilience and a determination never to give up on locating the victim, which they did. He couldn't have been prouder of them.
- Finally, Chief Jannone thanked the board for the support over the last four years. Collectively as a group we accomplished many things. Thank you for the privilege of being the Chief.
- Deputy Chief Marshall has submitted the grant for air packs, totaling \$225,196.38. An answer about the grant will be in October 2022.
