#### **CHIEFS REPORT:**

- Monday, May 2, 2022 7 Pm Search Drill @ Somerville Tower
- Scheduled Chief Isakson from county Fire Tactics for an 8-hour training seminar on October 22, 2022. The total cost is \$4500.00, and the details are explained in new business.
- Car 30B had work done to fix the headlights and new brakes. It will be at Bridgewater Chevy for a recall as well. A 5-year replacement program was discussed when the vehicle was purchased.
- Requesting a workshop to discuss moving forward with the previously discussed replacement plan.
- Contacted Fullerton Ford regarding a recall on Utility 30.
- Contacted Winner Ford, Alan Zimmerman, regarding the issue with the backup sensor on Utility 30. No return phone call.
- Tower 30 returned from Fire & Safety and is back in service.
- Rescue 30 committee is set for a pre-construction visit to Pierce in July 2022.
- Hose testing was completed, and the report is attached. New Hose will need to be ordered along with attempting to fix some of the hose that failed.
- Art Akins provided a quote to detail all apparatus except for Car 30B. The quote is consistent with last year at \$3.325.00.
- No return call from Jerry Naylis regarding ladder and pump testing.
- We need a vendor to conduct our aerial testing.
- Received a quote from M&W communications for the purchase of tri-band mobile radio for Utility 30. The price is \$7,327.25 installation included. All pricing is state contract. Delivery time is up to 4 months.
- Radio bands were discussed at the Somerset County Chief's meeting. Dave Frauenhiem believes that the UHF trunk system will be offline in 3 years.

- On 4/6/2022 Finderne Fire Department responded to a gas leak on RT. 22 involving the electric division of PSE&G. We responded at 9:49 and cleared at 3:00 p.m. Chief Marshall contacted OEM Edwards and advised him of the incident. He stated he did not believe this incident fell under the Township's Ordinance for reimbursement.
- Requested a closed-door meeting after the close of the public meeting.

President Spolarich reported the fire company sent out letters for low responders to declare their intentions of commitment to the FD by the July meeting.
