

**MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL  
APRIL 21, 2022 COUNCIL CHAMBERS**

The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Thursday, April 21, 2022 at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807 & via Live Online Broadcast.

Council President Kurdyla led the audience in the Pledge of Allegiance.

**Council Reports**

Councilman Kirsh

- Attended a Green Brook Flood Control commission meeting

Councilman Norgalis:

- Play ball! Youth Baseball returns to our town as the BBI opening day has passed and the Bradley Gardens Little Loop opening day is coming up this Saturday.
- Today as you will shortly see, the Bridgewater Council agenda is filled with roadwork projects as the Council and Administration move forward aggressively to fulfill a promise made to jump start the 2022 Road

Improvements as part of our five years plan. In prior years we able to take advantage of the relatively stable price of oil to expand the list of roads being improved. Sadly this year owing to the soaring oil costs we will probably not have that benefit but remain committed to overall road improvements

- Our governor has proudly announced that the sale of residential marijuana begins today April 21st. A resident asked me where he could buy marijuana in Bridgewater for personal use meaning non-medical. My candid answer “you can’t, but a listing of places is on the web”.
- April is big month for religious observance. Jewish Passover is celebrated from Apr 15th thru April 23
- Easter as it's commonly celebrated in the United States falls on the first Sunday after the first full moon of the spring equinox (always between March 22 and April 25), while Orthodox Easter is celebrated on the Sunday after the first full moon after Passover (between April 4th and May 8th.) which this month is April 24th
- The Holy month of Ramadan on the Muslim calendar requires fasting from Fri, Apr 1, 2022 with the breaking of the fast on either Sun, May 1, 2022. or May 2.

Councilman Pedroso:

- There was a recent accident which resulted in the tragic loss of a young girl who was on a bike and involved in a car accident. Councilman Pedroso noted there are fast moving vehicles that cut through that location in an attempt to avoid the light and make that zigzag. Councilman Pedroso questioned whether administration has looked into a solution to deal with this issue. Michael Pappas, Township Administrator stated the Engineering and Police Department have been engaged in looking at possible options that could be considered. Sight visits have been done by all appropriate township officials in order to canvass that location and entire neighborhood. He has met with someone from the Police Department in order to begin to outline some of the options that we can consider, many of which will likely come to the Council for action.
- Councilman Pedroso stated he has been exploring the idea of having a cultural committee in the township that would be focused on dealing with diverse cultures in Bridgewater and how we can better incorporate them in functions. Councilman Pedroso requested that Township attorney Corsini provide him information about the legalities of establishing such a

committee and how it can be done. Township Attorney Corsini advised this should be done by Ordinance and inserted into township code.

**Councilman Ring:**

- Last week the Somerset Patriots posted their baseball games.
- The Board of Adjustment recently met and approved a very small subdivision, age restricted, 62 and older complex off Chimney Rock Road in Martinsville. There were numerous conditions attached to their approval.

**Council President Kurdyla**

- Proud of the resolutions that are on the agenda this evening to fulfil a commitment to the township for road improvements for the next few years.

**Mayor's Reports**

**Public Comment**

Members of the public wishing to address the Council on any matter will be allowed two minutes to speak unless there are unusual circumstances.

On motion of Councilman Norgalis, seconded by Councilman Kirsh, the meeting was opened to the public for comment.

Monica Travis, who resides at the intersection of third street and Fulton Avenue was present.

On April 2<sup>nd</sup>, a child was struck and killed by a vehicle while she was riding her bicycle directly in front of her house. Ms. Travis stated our community needs Council's help with this to ensure it doesn't happen again. She further expressed she and her neighbors are all living in constant fear of letting their kids out of the house and as such, better safety measures are necessary. In that regard, Ms. Travis offered she would be more than happy to point out the problems which are not just about the influx of traffic but also include parking of utility vehicles that cover the stop signs and create blind spots etc.

Council President Kurdyla advised there will be a sight visit with all involved township officials this coming week. Ms. Travis will be advised of the upcoming meeting in order for her to be in attendance.

Dianna Nye, 671 Country Club Road was present

Ms. Nye stated Talamini at Country Club is becoming a hot haven for stop sign blows. Every reflector along the road has been taken out by cars jumping the

curb. Ms. Nye stated her mailbox has been taken out multiple times as people use County Club to bypass the traffic on Route 206. She offered there are countless careless driving acts on this road as cars are going well over the speed limit.

Ms. Nye expressed her family is no stranger to accidents but the other things that are happening are careless acts of driving. She asked the town to immediately reduce the speed limit on Country Club Road as she has one handicapped child and even though he has a tracker and she keeps her eye on him, he can still run out into the road. She offered a street light or two at that intersection may be helpful adding there are stop signs with LED lights with cameras that can capture people blowing the stop sign. Ms. Nye requested Council to consider installing a 'special needs child' sign by that intersection.

Jessica Demcsak, 660 Country Club Road, Bridgewater, NJ 08807

She spoke in support of Ms. Nye's comments noting that her home is 2-homes away from where the accident occurred. She added their street is incredibly dark and that if unfamiliar with the Talamini stop sign, people can get disoriented and catastrophic accidents could occur. She offered a blinking stop sign would be helpful.

Cathy Franco, 766 Weemac Road, Bridgewater, NJ 08807

Grateful that this meeting is being streamed but requested that the public is offered the opportunity to provide public input from home moving forward. Was glad to see the residents that have come out to speak out regarding safety issues noting these issues are significant in the entire town. She offered that in Montgomery township, the police used to park a retired police vehicle on a side of the road with a dummy dressed up as a policeman and those who passed through that road slowed down. Ms. Franco added we need to take a more active role to get people to slow down. Ms. Franco further stated resolution 12o talks about repairs needed and hoped the engineers can observe the roads during all weather types. Furthermore, she stated resolution 12f is about temporary budget appropriations and wondered when we may be able to see a budget proposal as we are 4-months into the current budget year.

On motion of Councilman Norgalis, seconded by Councilman Ring, the public comment portion was closed.

This Ordinance will allow us to amend our fee structure for Towing and Storage ordinance in order to be more comparable to State police fees. It was confirmed the proposed fees are consistent with surrounding towns.

Township Administrator Pappas stated this Ordinance will allow us to update the sewer connection fee from \$550.00 to \$4,539.00 per new residential unit in order to accurately represent our current day financials. The fee was determined by conducting a detailed analysis of the costs that the Public works department incurs. Neighboring municipalities were also surveyed and the proposed number is comparable. After considerable discussion, there was consensus that this Ordinance will become effective 60-days after final passage.
