MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL July 18, 2022 COUNCIL CHAMBERS

The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Monday, July 18, 2022 at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807 & via Live Online Broadcast.

Council President Kurdyla led the audience in the Pledge of Allegiance.

Council Reports

Councilman Kirsh

- Councilman Kirsh stated he has been an advocate to ensure we pursue all appropriate reimbursements from the Federal and State government for IDA related expenses. Administration has moved forward with ensuring that letters have gone out to our various representatives who can financially advocate for our needs.
- There has been some follow-up conversation with Somerset County concerning recycling. The takeaway includes a reinvestigation of the number of units that we will be billed for and that moving forward, for

the 2023 year and beyond, that information will be accurate. Additionally, we anticipate our recycling bill will be on hand either late 2022 or very early 2023 so that we are well advised of our financial obligations in good time.

• The S&P Ratings Firm has confirmed the township achieved a positive bond rating which is noteworthy in the challenging and uncertain times that we faced. Councilman Kirsh stated we have had to make very difficult decisions and do things we did not want to do in the face of considerably reduced revenue and other challenges. The positive bond rating reinforces that the actions Council has taken have been the right ones.

Councilman Norgalis:

- Last Saturday, Somerset County held a secure shred event at their North Garage site which is located in our town on Chimney Rock Road. For a 9am start, County residents started lining up at 8:30am. Numerous shred trucks were there and once opened, things moved smoothly.
- Millions of Muslims worldwide this month celebrated Eid al-Adha, an Islamic religious festival commemorating Prophet Abraham's faithfulness to God after being tested with the unfulfilled command to sacrifice his son. The holiday also marks the end of the yearly Hajj pilgrimage in Saudi Arabia.

Councilman Ring:

- Attended the wake of former Martinsville Rescue Squad Chief Debbie Manna who unfortunately passed away after a long illness.
- This past Tuesday, the Planning Board held a regular meeting where they
 considered one small application related to a previously approved older
 home that will be rehabilitated into a subdivision for a second home. This
 applicant is requesting an extension on previously granted approvals.
- As a follow up to our last Council meeting, Councilman Ring stated he
 received some communication from the daughter of former late Mayor Al
 Griffith who was very appreciative of the comments offered at the last
 Council meeting and asked for copies of his full speech when he took over
 as the first Mayor under the Falkner Act.

Proclamation

HONORING THE LIFE OF FORMER MARTINSVIILLE RESCUE SQUAD CHIEF DEBBIE MANNA AND HER CONTRIBUTIONS TO BRIDGEWATER

Matthew C. Moench, Mayor read the following proclamation:

WHEREAS, Debbie Manna was born in Passaic, New Jersey and was raised in Old Bridge, New Jersey, before moving to Martinsville with her family in 2006; and

WHEREAS, Debbie and her husband of 42 years, Jerry, raised their two daughters, Faith and Lauren, both of whom now have families of their own; and

WHEREAS, Debbie spent 36 years at Johnson & Johnson working as their Chief Environmental Health and Safety Officer before retiring on June 30th, 2022; and

WHEREAS, Debbie was passionate about helping others, devoting her last 15 years serving her community by volunteering with the Martinsville Rescue Squad; and

WHEREAS, Debbie's dedication to the Martinsville Rescue Squad and its mission led to Debbie becoming the first and only female Chief in Martinsville Rescue Squad's history, serving as such for 10 years; and

WHEREAS, Debbie always put the needs of her community first and foremost, and was a shining example of a true local hero; and

WHEREAS, to the regret and sorrow of all who knew her, Debbie Manna sadly passed away on July 7th 2022, after a long and brave baffle with cancer; and

NOW THEREFORE, BE IT RESOLVED, that Mayor Matthew C. Moench and the Bridgewater Township Council express on behalf of all residents of the Township of Bridgewater, past, present, and future, their gratitude and deepest sympathy to the Manna Family and join them in celebrating the life and achievements of one of Bridgewater Township's finest residents.

On motion of Councilman Norgalis, seconded by Councilman Ring, the meeting was opened to the public for comment.

Jennifer Loughran, 716 Falcon Court, Bridgewater, NJ 08807

Thanked Mayor Moench for his attendance at the skating for the Raritan Food Pantry.

In light of the efforts to move forward and discuss the Master Plan, Ms. Loughran discussed Brown Park noting the history of the Park is pretty cool. In the early 1800s, William Bradley was buying up all the land that is now Bradley Gardens but there was one farmer, Alfred Brown who refused to sell to him. It was through a partnership with Anna Studdiford and her son that the farmland was preserved. After Mr. Brown and later, Mrs. Studdiford passed on, her son Walter went on to ensure that his life long neighbor and friend's land would be preserved as Alfred Brown Park. It is a beautiful and active park that is Central to Bradley Gardens and is adjacent to Bradley Gardens Elementary School. Ms. Loughran however noted that the park is in desperate need of remediation that is beyond the hard work and diligence of the Department of Public Works. The old hockey rick is awful, the parking lot is a mess, there is no lighting, the pads are not great and the tennis courts are rapidly declining. In the short term, it would also be great to have some shade on the tennis courts as they are barely usable in the summer for about 3 to 4-hours during the day. Ms. Loughran also suggested that administration tap into the community to promote volunteerism and cultivate stewardship. People are willing to help because this park is a landmark to be proud of as it represents the essence of good neighbors and is a legacy as one of the earliest wins against over development in Bridgewater.

Steve Wise, 84 Village Circle, Bridgewater, NJ 08807

Stated he was present in support of his neighbors regarding the Green Knoll Grille (GKG) noting concern over excessive noise pollution and lack of parking. He offered he has made several complaints because GKG customers take up all the parking and he has in the past had to park farther down from his home.

Victor Caliman, 79 Village Circle, Bridgewater, NJ 08807

Mr. Caliman stated he was concerned about reading his prepared speech because it was taken out of context by a member of the press at the last Council meeting. He added he was present as one of 30-families who have concerns about the Green Knoll Grille (GKG) and not as an individual with a personal vendetta. He further stated GKG has a right to operate but reiterated the noise concerns emanating from that establishment. The Patch published an article that was very imbalanced and that made mention of just his family and as such was fearful for himself, his family and his property. In that regard, Mr. Caliman stated on the record that he is not against the ability of the GKG to operate. He added he cares about our community and wants to be good neighbors to GKG but also wants them to be good neighbors in return.

On motion of Councilman Norgalis, seconded by Councilman Ring, the public comment portion was closed.
