The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Monday, August 15, 2022 at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807 & via Live Online Broadcast.

Councilman Kirsh read the following proclamation:

#### GREEN KNOLL GRILLE

Public Hearing & Final Action Ordinances Township Attorney Chris Corsini explained that based upon a police report and body cam footage that we have, a violation on the liquor license for the Green Knoll Grille (GKG) occurred on the 10<sup>th</sup> of June. The hearing tonight is to determine whether or not provisions of the license should be invoked for suspension adding the Council can either suspend or dismiss as they see fit. This is not a hearing on the renewal of the actual license which is also on tonight's agenda but a hearing with regard to the June 10<sup>th</sup> incident.

Acting Police Chief John Mitzak and Police Officer Bryce Forke were present.

David Cassidy interrogated Officer Forke then concluded the June 10<sup>th</sup> incidence was a one-time de-minimis violation without need for excessive penalty. He opined suspending the license for a day was excessive and offered Council should consider another remedy such as a minor fine or a warning.

Township Attorney Corsini offered that Council should open the meeting to the public to speak with regard to the GKG before making a final determination on this matter.

GKGMembers of the public wishing to address the Council on any matter will be<br/>allowed two minutes to speak unless there are unusual circumstances.

# Comment

On motion of Councilman Ring, seconded by Councilman Norgalis, the meeting was opened to the public for comment.

#### Lisa Dichiara, 15 Tullamore Court Ringoes, NJ

They have owned GKG for almost 26 years and have been good corporate citizens that serve the community. Nothing has changed as they have been having live outdoor entertainment for as long as she can remember. They cater to many different people and employ many Bridgewater residents as well as their children who come home from college looking to work in the summer. They give back to the community, donate to the animal shelter, homeless shelter and different charities. Ms. Dichiara offered they are located on a busy, heavily travelled highway off Route 202/206 and that the cars are louder than any live outdoor entertainment. She added there was a professional noise meter study done years ago which proved the highway noise was much greater than the GKG and after that study was completed nothing much was mentioned for a while.

Ms. Dichiara stated only the GKG has been given the strictest restrictions in all of Bridgewater. She added they had over 1600 signed petitions in support of the GKG and asked that Council not take away the outdoor entertainment option for those that love it.

# Greg O'Neal, 1134 Concord Drive, Bridgewater, NJ 08807

Offered he and his family frequent the GKG and that they and others have wonderful times there. COVID has done a terrible thing to society and affected many people in so many different ways but GKG brings back normalcy and live music affects people positively. He offered the penalty should be minimized as the violation is de-minimis.

# Nelson Cantillo, 352 Berkshire Valley Road, Roxbury, NJ

Stated he is one of the band players and it has always been made very clear what noise levels and hours of playing live music were. Occasionally, some exceptions occur but the management has always made a very distinct mention of making sure the bands comply with the hours stipulated. Mr. Cantillo stated he was present when a decimal meter was activated in order to ensure they complied and also noted the music levels were much lower than the noise produced by the traffic. Mr. Cantillo added GKG is an amazing employer.

# Michael Craggan, 6 Valley Road, Manalapan, NJ

Stated he travels 45-minutes with his family and friends to get to the GKG. He offered rules are confusing and that noise levels at the GKG are lower than the noise emanating from the highway.

# Terry Beck, 21 Bloomingdale Drive, Hillsborough, NJ 08844

Stated she is a faithful customer of GKG and offered the highway noise is way higher than the noise from the band.

#### Kathy Franco, 766 Weemac Road, Martinsville, NJ 08836

Stated the residents at the Crossroads are asking that the GKG act as a good neighbor and as such would support a one-day suspension of the GKG liquor license due to the violation because this is not the first infraction by the GKG.

# Brigid Lorncz, 284 Old York Road, Bridgewater, NJ 08807

Offered she is an employee at GKG and that a day makes a big difference for a server or bartender. GKG has done so much for her and for the residents and asked that Council consider those that will be affected by the 1-day suspension.

# Bryan Maskeris, Basking Ridge, NJ 07920

Offered the GKG brings people together and asked the Council reconsider the repercussions of a suspension. He added the noise levels are much lower than the highway noise.

# Stephanie Villa, 263 Seville Court, Bridgewater, NJ 08807

Stated she is a new Bridgewater resident but grew up in Hillsborough and GKG has been a place that she and her family frequent and enjoy. She asked that Council reconsider the penalty noting a one-day suspension makes a big difference for small businesses.

# Dale Tothe, 2 Badminton Court Sea Bright, NJ 07760

Stated he is on a band that has performed at GKG for many years. He offered it is unusual that those who complained about the GKG are not present today to represent themselves and offer their complaints. He added the musicians watch the decibels very closely and that GKG is a great employee. Mr. Tothe asked that the penalty be minimized.

# George Bateman, 94 Catherine Lane, Bridgewater, NJ 08807

He asked that the Council make the public aware there are a lot of thieves operating in our town and are not able to be policed by the Police Department because they are doing this electronically.

# John Arcoleo, 1110 Washington Valley Road, Basking Ridge, NJ 07920

He questioned the affordable housing agreement with GCP that is on tonight's agenda noting the property is not appropriate for this. Mr. Arcoleo was advised the site is already developed as a hotel. The township had an obligation for 40-affordable units which will be transferred from the Center of Excellence site on Route 202/206 to this site. This proposal will fulfil our obligation without any additional development and with much less impact.

#### Kathy Franco, 766 Weemac Road, Martinsville, NJ 08836

Stated she is concerned with the R-SEED agreement noting the apartments will likely impact our school system and wondered if there have been any discussions with the school district as to how that will affect their assignment of students to schools. Ms. Franco also questioned the monies being given to the hotel to develop affordable housing and was advised it is to offset the cost which is substantially less than the going rate for an affordable housing unit contribution.

Ms. Franco also questioned how the township plans to meet the budgetary implication of changing the composition of the Police Department and having additional police officers. Ms. Franco was advised the Ordinance does not add positions, it provides the option to add.

On motion of Councilman Ring, seconded by Councilman Norgalis, the public comment portion was closed.

PresentationSOMERVILLE ROAD TRACT UPDATE/ CONVEYANCE OF TOWNSHIP LOTS<br/>Thomas Genova, Director of Municipal Services made presentation as follows:

#### Somerville Road Tract

The Somerville Road tract has frontage on Vogt Drive and Somerville Road. It was created by a map titled "Mountain Side Park" filed with the Somerset County Clerk on November 9, 1907 and a map titled "Somerset Heights" filed with the Somerset County Clerk on July 28, 1910. These maps created lots measuring 20' X 100' fronting on paper streets. The streets were never improved. The total tract contains approximately 40 acres. The majority is undeveloped.

I prepared a Tax Map to show the ownership with the color green for Bridgewater Township owned lots, the color yellow represents privately owned lots. The color pink represents developed lots where single-family homes exist. The Senior Center is located on Block 575.

It is in the Townships best interest to complete the assembly of land in this tract. Currently there are 12 privately owned lots North of Somerville Road and 4 privately owned lots South of Somerville Road. I have contacted the remaining privately-owned lots. Many owners have expressed an interest in selling to the Township. I will be working with the Township Attorney's office to have ordinances prepared for the upcoming council meetings.

When the assembly is completed, the next step is to vacate all of the paper streets.

#### Conveyance of Township Lots

I am in the process of evaluating Township owned lots. As part of that process I have identified four lots where there is no public use or future purpose. The lots do not comply with the Township zoning ordinance. The Township ownership creates maintenance and liability issues. The Township has no use for these lots. Selling the lots will put the property back on the Tax Rolls. The best use for the lots would be to sell them to the adjoining owners. NJ Statutes 40A:12-13 (b) (5) "A sale to the owner of the real property contiguous to the real property being sold; provided that the property being sold is less than the minimum size required for development under the municipal zoning ordinance and is without any capital improvement thereon" This is subject to the Township attorney's office to determine the same.

Block 548 Lot 2 has 50' of frontage on Highland Avenue and Allen Road. this is an isolated undersized lot. Adding this lot to the adjoining lot would make it more conforming.

Block 154 Lot 12.01 has 20' of frontage on Maple Street. Flag lots are not permitted. Adding this lot to the adjoining lot would make it conforming with the zone and neighborhood.

Block 517 Lot 4 has 20' of frontage on Monmouth Avenue. The property to the East is developed with a single-family home. The property to the West is owned by the Township. Combining the 20' lot to this property would bring it into conformance with the zone and provide a buffer. I have been in contact with the owners of Block 517 Lots 16 & 17 who have an interest in selling the same to the Township.

Block 243 Lot 7.01 is a landlocked parcel. This is a very unusual case in the back yards of a residential subdivision.

Following the presentation, Mr. Genova fielded questions from the governing body.

**Recess** Council President Kurdyla called for a 5-minute recess at 9:30pm. The meeting resumed at 9:35pm with all members present as before.

# AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF BRIDGEWATER TO CREATE THE RMDU-26 MULTIFAMILY RESIDENTIAL ZONE AT THE SITE OF THE HYATT HOUSE, BLOCK 400, LOT 7 LOCATED AT 530 ROUTE 22.

Township Administrator Pappas stated this is a proposed Ordinance change that would permit the conversion of the Hyatt house hotel to a multifamily apartment complex. 40 of those units are slated to meet the 40-unit affordable housing obligation.

Councilman Pedroso stated he supports meeting the COAH obligations. However, he has never voted in favor of an apartment complex in Bridgewater and feels very strongly that Bridgewater should not become an apartment community. He added it appears there is a financial incentive for the the hotel owner to move forward with this and not sure why tax abatements and benefits should come at a cost to Bridgewater taxpayers. Councilman Pedroso stated he will address this question with administration in the course of the next few weeks but will not be voting in favor of this Ordinance at this time.

RATIFYING AND MEMORIALIZING APPROVAL OF THE BRIDGEWATER MUNICIPAL EMPLOYEES ASSOCIATION AGREEMENT FOR THE PERIOD FROM JANUARY 1, 2019 THROUGH DECEMBER 31, 2024 Township Administrator Pappas stated administration has undergone extensive negotiations with the BMEA representatives. The contract expired in 2018 and this year, active discussions were engaged and they were very amendable to extending the contract beyond the three-year term.
