# Council Reports

### Councilman Kirsh

 Sent his thoughts and best wishes to those impacted by Hurricane Ian in multiple States.

- Bridgewater Township and Bridgewater United Soccer Club will hold a fall food drive on Wednesday, October 12<sup>th</sup> thru Sunday, October 16<sup>th</sup>. This initiative was launched about a year and half ago to benefit the food network of Somerset County that is located within our township. A tent will be erected in the courtyard area of the municipal building near the Police Department. We are looking for non-perishable foods, laundry and dish soap, paper towels, toilet paper and other personal care items. Glass containers or expired food will not be accepted
- Two weeks ago, had the privilege to represent our community at the Somerset County Bar Association installation event where Steve Warner, Esq. was installed as president
- Had the privilege of attending the last two home games for the Somerset Patriots last week where they won the Eastern League Championship.

# Mayor's Reports

# Mayor Matthew C. Moench

- Thanked everyone who made the Community event this year a great success. The partnership between the township and JCC and the Bridgewater Commons Mall continues to grow and expand. Mayor Moench thanked the Office of Constituent Relations, the Police Department, Public Works, Fire and Rescue responders and all organizations that participated. It was a very great event.
- Thanked everyone that made Bridgewater Restaurant Week a success including the restaurants that participated. This was our second year trying to highlight restaurants located within Bridgewater Township. Mayor Moench thanked the Office of Constituent Relations who helped to get that initiative moving. He further encouraged all our restaurants to participate and all the residents to support our local restaurants during restaurant week next year
- With regard to the 2022 Road project, road work is ongoing. Some projects are completed while others are in different stages of work. One or two projects have supply chain issues which has caused a delay. Mayor Moench stated we continue to bring the 2022 road program to a conclusion and in the not too distant future, we will begin to talk about the 2023 road project

 Mayor Moench stated he will be running in the NY City marathon in a little over a month and will be doing it to raise money for Children's Specialized Hospital. More information will soon be forthcoming.

## Proclamation FIRE PREVENTION WEEK

Mayor Moench read the following proclamation:

WHEREAS, Bridgewater Township is committed to ensuring the safety and security of all those living and visiting our Township; and

WHEREAS, fire is a serious public safety concern, both locally and nationally, and homes are where people are at the greatest risk of fire; and

WHEREAS, roughly two-thirds of home fire deaths resulted from fires in which no smoke alarms or no working smoke alarms were present; and

WHEREAS, working smoke alarms cut the chance of dying in a reported fire in half; and

WHEREAS, residents who have planned and practiced a home fire escape plan are more prepared and will therefore be more likely to survive a fire; and

WHEREAS, Bridgewater residents will make sure their smoke and carbon monoxide (CO) alarms meet the needs of all their family members, including those with sensory or physical disabilities; and

WHEREAS, the dedicated volunteers of the Bradley Gardens Fire Company, Country Hills Fire Company, Finderne Fire Department, Green Knoll Fire Department, Martinsville Fire Department, and North Branch Fire Company are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

WHEREAS, informing the public about the importance of smoke alarm installation and maintenance serves an essential step toward increasing the public's safety from home fires; and

WHEREAS, Bridgewater residents are dedicated to public education measures and are able to take personal responsibility to increase their safety from fire, especially in their homes; and

**WHEREAS**, this year is the 100<sup>th</sup> Anniversary of Fire Prevention Week and the 2022 Fire Prevention theme for this period is "Fire Won't Wait. Plan Your Escape"; and

NOW THEREFORE, I, Matthew C. Moench, and the Bridgewater Township Council do hereby proclaim October 9<sup>th</sup> to 15<sup>th</sup>, 2022 as Fire Prevention Week and we encourage all residents to protect their homes and families by heeding the potentially life-saving messages of Fire Prevention Week 2022, to support the many public safety activities and efforts of our fantastic volunteer Fire Departments, and challenge all residents to take responsibility for their fire safety and check their homes and ensure that they have a working smoke alarm on every floor of their house and outside their sleeping areas, as well as at least one working carbon monoxide alarm and have planned and practiced their home escape plan.

# Public Comment

Members of the public wishing to address the Council on any matter will be allowed two minutes to speak unless there are unusual circumstances.

Above residents asked Council to address safety concerns with high school students, some of whom are considered walkers while others drive. The parents offered that the corner of John Christian and Garretson Road has become scary. For this reason, parents no longer allow their children to walk as there have been numerous close call accidents because cars are not stopping. The parents further stated they have been to the superintendent of schools who advised this is a township concern. These parents offered a crossing guard should be provided to assist the children cross the roads during school crossing times.

Lieutenant Brian Blath stated they have been made aware of the concerns and advised the task of assigning crossing guards falls with the Police Department. In that regard, they will review their current deployment of crossing guards and staffing levels and barring any emergencies or volume, they will immediately look into remedying this issue moving forward. Lieutenant Blath however advised there is a shortage of crossing guards but that the Police Department will look into what options they have in addressing this situation including outsourcing crossing guards, having the police temporarily step into these positions and also conducting a hazardous busing investigation.

# Dorothy Driscoll, 16 Claire Drive, Bridgewater, NJ 08807

Had questions with regard to the ordinance on tonight's agenda regarding removing warehouse uses as a permitted use in certain zones. Mayor Moench offered there are certain areas of the township that have warehouses as a permitted use. This Ordinance will remove that use as a permitted principal use. For those warehouses that are already in existence, they will continue to operate but new warehouses, moving forward, will need Board of Adjustment approval for a Use variance in order to be allowed to operate.

### Discussion

### **ESCROW FEE APPLICATIONS FOR LAND USE BOARDS**

Thomas Genova, Director of Municipal Services was present and offered that at the last Council meeting, there was discussion with regard to escrow fees. When an escrow account contains insufficient funds to enable the municipality to perform required application reviews or inspections, it creates problems as the township professionals and consultants cannot receive payment for services rendered. This also creates additional work for Township employees in attempting to collect the funds. To improve the consistency and amount of land use applicant escrow replenishments, an amendment of Chapter 126-35 regarding escrow fees is required. It will simply clarify that whenever an escrow account falls below 25% of the original escrow deposit it will be replenished with 75% of the original escrow deposit. This will ensure that the Township's consultants are able to timely review and inspect land use applications and improvements and receive remuneration for the same.

Mr. Genova stated the expectations of applicants regarding replenishment of escrow fees was never memorialized which causes confusion with the applicants who think it is a one-time deposit. He added the consultants that draw from these accounts are the planner, engineer and the Board attorneys who review deed restrictions, developer's agreements etc.

Following the presentation, Mr. Genova fielded questions from the governing body.
