MASTER PLAN RE-EXAM REPORT [A MASTER PLAN AMENDEMENT] AND AMENDMENT TO THE LAND USE ELEMENT OF THE MASTER PLAN

Ms. Doyle explained that the State Planning Commission's Draft Warehouse Siting Guidance publication (received by the Board at a prior meeting) prompted this Re-exam/Amendment.

Chairman Vescio solicited comments from the Board at 6:04. Calling it an important first step, Mayor Moench explained that this guidance from the State would allow municipalities to "hit the pause button" while looking at the impacts of warehouse development. Councilman Ring clarified that this would not impact pending applications.

MASTER PLAN CONSISTENCY REVIEW
