### Kelly Clarke, 703 Wicklow Way, Bridgewater, NJ 08807 was present

Offered she has lived in Bridgewater for thirteen years and was glad to hear council comments regarding Bridgewater being a community that values quality of life adding she moved here for those reasons.

Ms. Clarke stated she lives in the rental community "The Village" and was present with many of her fellow neighbors to discuss the issues they are facing since the new management company "Living Emerald" took over the property. She added the residents

have tirelessly tried to protect our community. They have combated the issue of fire hazards as the annual dryer vents have not been cleaned for over 3-years. They have spoken to the fire marshal and the police about the safety hazards including no street lights, wood piles lying about the property with giant nails that are dangerous for small children. There are mold issues, plumbing issues that have gone unaddressed for 28-weeks while mold continues to grow, leaks continue to happen and exposed ceilings that are not being maintained or addressed.

Ms. Clarke opined the property has been abandoned. There is no leasing office on ground, no maintenance crew on ground and the residents, which include many senior citizens, live with arbitrary fees that are unethical and illegal. There was a 19% rent increase and arbitrary fees for nonexistent features such as club houses and gyms. Ms. Clarke asked the township to assist the residents of "The Village" in order to maintain their quality of life. She offered New York is also assisting and protecting their residents from the same property management.

Ms. Clarke was asked to provide her contact information to Township Clerk Doyle. She was further advised Township Administrator Pappas will reach out to her and offer assistance to the degree that the township is able to help.
