WHEREAS, the Annual Budget for Bridgewater Township FD No. 4 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 14, 2022; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$734,681.57 which includes an amount to be raised by taxation of \$699,573.57 and Total Appropriations of \$734,681.57; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 14, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

The total budget is increasing from \$720,323.62 in 2022 to \$734,681.57 in 2023. The total budget was increased by the 2% cap increase of \$13,704.31 and was also increased by the additional ratable valuation of \$653.64.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Office expense was decreased by \$10,051.05 due to the digitization of all paper records that was expensed in 2022 and was a one time expense. Total Interest Payments on Debt was decreased by \$3,891 due to more of the debt payment allocated to principle. Total Capital Appropriations has a net increase of \$20,089 due to the 2% Cap Increase, Increase in Ratable Valuation, decrease of Office expense and a 2% increase of various expenses.

The debt service for 2023 reflects the payment on debt in the amount of \$101,192 which includes interest of \$437. The lease period ends in 2023.
