# MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL FEBRUARY 1, 2024 COUNCIL CHAMBERS

The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Thursday, February 1, 2024, at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807 & via Live Online Broadcast.

Council President Ring read the following announcement:

Councilman Kirsh:

Reports

Council

- On January 2, 2024, Councilman Kirsh had the opportunity to attend the reorganizations of Green Brook and Raritan as well as the post-meeting celebration for Bernards Township.
- The Budget Committee met on January 22, 2024, and discussed the timeline for this year. Councilman Kirsh stated that the expectations are going to be similar to last year, with the budget introduction and adoption around May, 2024. The committee also discussed monthly reporting that they will begin to receive from the CFO in order to have additional insight not only to the budgeting aspect but the spending side as well.
- Attended the Somerset Patriots event on January 25, 2024.
- On January 28, 2024, Councilman Kirsh, along with Mayor Moench, attended the Kabhoom Robotics Drone Zone free workshop. Kabhoom is an organization out of Edison, NJ.
- Attended Cellares ribbon-cutting and was most impressed by a story that was shared by Bob Levis, a leukemia survivor, who was part of an early life-saving trial. Councilman Kirsh expressed that the Township should feel very proud to have a company like Cellares in Bridgewater.
- Councilman Kirsh attended the promotion ceremony and walk-out in the Police Department.
- The Planning Board will be meeting next week for their reorganization. The Zoning Board reorganized on January 23, 2024, with Jeff Foose continuing as Chair and Jim Weideli as Vice-Chair. The Zoning Board heard an interesting case regarding a storage unit company and the possibility that it will be turned into a warehouse. Councilman Kirsh stated that the governing body will be very critical in considering anything that involves warehousing.

Councilman Kurdyla:

- Attended the ribbon cutting of Cellares and believes the technology will be a tremendous asset for people who suffer from various illnesses.
- Councilman Kurdyla attended the Police Department ceremonies acknowledging two Lieutenants that were retiring and two individuals who were being promoted to Lieutenant and Sergeant.

• Councilman Kurdyla joined a tour of the Ethicon industrial site with a potential buyer. He also discussed with them the possibilities for Bridgewater Township.

Councilman Norgalis:

- Had the honor of swearing in the Green Knoll Rescue Squad line officers as part of their 2024 Executive reorganization. The township owes a debt of gratitude to all of the volunteers whether they be Rescue Squad or Fire. Their selfless dedication makes this a better town.
- Attended the walk-through of the Ethicon buildings on Route 22 and Country Club Rd. A nationally known company is considering buying the building and potentially deeding a portion of the property to the township.
- Attended the annual Patriots Baseball Team celebration along with my fellow Councilmen as the Patriots get ready for their 2024 Season. Coowners Josh and Jonathan Kalafer were the keynote speakers, talking about their vision for the future. Patriots get-togethers cannot be complete without talking about philanthropist Stephen Kalafer and the part he played in developing the team and the ballpark 25 years ago.
- Attended the Bridgewater Police Promotion and Retirement Walk-Out Ceremony. Officer Kevin Florczak was promoted to Sergeant and Sergeant Todd Mele was promoted to Lieutenant. Lieutenants Kevin Lamey and Brian Blath both retired after achieving 25 years of service.
- Attended the Cellares ribbon cutting on their, soon-to-be operational facility, actually a factory, located at 95 Corporate Dr off Routes 202 /206. This facility will engineer cancer-fighting drugs on an individual patient basis.

Councilman Pedroso:

Attended Cellares ribbon cutting ceremony. Councilman Pedroso stated that Cellares is a new company in Bridgewater that modifies human cells and produces new ones to fight cancer and other diseases. He explained that this is the world's 1<sup>st</sup> Integrated Development and Manufacturing Organization (IDMO). Cellares has turned automated cell therapy into a machine process. He added that the company can increase the production of cell therapy by 10x and lower costs by 50%. Councilman Pedroso hopes that Bridgewater can be a HUB for providing very valuable and needed life-saving cell therapies for those in the U.S. and around the world. He congratulated the founders and CEOs of Cellares for their

game-changing innovation.

Council President Ring:

- The Budget Committee met to discuss the 2024 road program and the corresponding required funding. The committee also discussed a potential timeline for the 2024 budget and stated that additional information is forthcoming.
- Participated in the Somerset Patriots end-of-the-season recap event.
