- 2) Tower 30 is complete.
- 3) First Due has been started, Administrator Jannone has completed the first three assignments to move forward to the next phase. Next meeting is scheduled for next week.
- 4) American Water has notified assistant Chief Ruscetta that the boat motor will be delivered this week. Training exercises will follow.
- 5) New Thermal cameral has been purchased for the 24 Tahoe, it is scheduled to start outfitting next week.
- 6) Power washer is purchased and in service.
- 7) Car 30 Tires are done; mechanic said the back brakes will need to be done soon.
- 8) Engine 303 pump failure is being addressed and should have an answer soon. It's recommended to replace all tires due to the age. Cost for the tires from Richie's is \$2,318.36.
- 9) Engine 302 it was recommended by Fire & Safety that the two mismatched rear tires on the right side be replaced. However, if only those two are replaced it could affect the ABS system. The price for two matching tires is \$1,450.00 and to do all 4 tires in the rear is \$2,900.00.
- 10) Communications workshop was completed at the 911 center. New radio changeover is scheduled for 2026.
- 11) Under carriage treatment started on the Chief's vehicles.
