The Division of Public Works is seeking a full-time gas/diesel Heavy-Duty Truck Mechanic to repair and maintain various types of Public Works vehicles and equipment. This includes, but is not limited to, light medium and heavy trucks, loaders, back-hoe, snow/ice removal equipment and specialized road and/or landscape equipment. Must be capable of diagnosing and repairing both gasoline and diesel engines, hydraulic and air brake systems. Report for all emergency work to include snow and other emergency work (on 24-hour call) as required by the Superintendent of Public Works or his designee.

MINIMUM REQUIREMENTS

Must have (2) years' experience as a Heavy-Duty Truck Mechanic in vehicle/truck repair and preventive maintenance. One year of automotive technology training is desired but additional experience may be substituted. Additional requirements include ability to perform preventative maintenance, weld broken assemblies, operate snow removal equipment and operate shop equipment in a safe and orderly manner. Must be proficient in operating shop computers and diagnostic equipment. NJ Driver's License is required. CDL preferred.

SUPPLEMENTAL INFORMATION

- **Authorization to Work:** US citizenship is not required. Selected candidate must be authorized to work in the US according to Department of Homeland Security, US Citizenship and Immigration Services regulations.
